

Oregon Jewish Community Foundation Website Terms of Use

These terms of use are entered into by and between You and the Oregon Jewish Community Foundation (“we,” or “us”) The following terms and conditions (these “**Terms of Use**”), together with any documents they expressly incorporate by reference, govern your access to and use of <https://www.ojcf.org>, including any content, functionality, portals, and services offered on or through it (the “**Website**”), whether as a guest or a registered user.

Please read these Terms of Use carefully before you start to use the Website. **By using the Website, you accept and agree to be bound and abide by these Terms of Use and our Privacy Policy, found at [Privacy Policy](#), incorporated herein by reference.** If you do not want to agree to these Terms of Use or the Privacy Policy, you must not access or use the Website.

Changes to the Terms of Use

We may revise and update these Terms of Use from time to time in our sole discretion. All changes are effective immediately when we post them, and apply to all access to and use of the Website thereafter. However, any changes to the dispute resolution provisions set out in Governing Law and Jurisdiction will not apply to any disputes for which the parties have actual notice on or before the date the change is posted on the Website.
