Our Products

Phoenix Burst is a genAI-native technology product designed to fulfill mortgage business processes. Unlike glorified task list “workflow” solutions, our product actually performs work and serves it to a human in the loop for curation.

- ▶ **Burst for Compliance:** Understand and act upon change in hours, rather than months. We evaluate regulatory and compliance documentation, distill the changes into change statements, assign change statements to teams, and determine impact. We provide the result as a standard format Excel spreadsheet.
- ▶ **Burst for Software Development:** Either extend our compliance solution or use standalone to accelerate software development. We take compliance change statements or business requirements documents (BRDs) and generate a complete set of requirements, user stories, acceptance criteria, and test cases for immediate curation.
- ▶ **Burst Enterprise:** Complete the vision of mortgage process fulfillment. This interactive, visual value network connects objectives to radiated insights in a system that continuously scans, predicts, and alerts. This is currently in development.
