Applicants submitting water quality improvement proposals are required to submit project information through FieldDoc for 2026 SWG and WILD applications.

Applicants must create FieldDoc accounts and prepare a pact as part of their application.



LOCATION

Select an activity type from a standard list of practice types.



MODELS

Estimate environmental benefit like sediment and nutrient load reductions



METRICS

Track progress toward implementation for non-modeled, planned outcomes.
