Attendants follow four simple steps to issue violations quickly and professionally while avoiding conflict, hardware, and manual paperwork.

Step 1: Identify

An attendant spots an unpaid or unauthorized vehicle during routine lot monitoring.



Step 2: Activate

The violation is logged in the mobile portal and a QR-coded sticker is activated.



Step 3: Enforce

A non-adhesive, easily removable violation sticker is placed on the driver's side window.



Step 4: Resolve

The parker scans the QR code, views the violation, and completes payment on their phone.

Branded signs and intuitive instructions make it easy for guests to understand Enforcement Lite — helping them resolve violations quickly, without confusion, apps, or conflict.



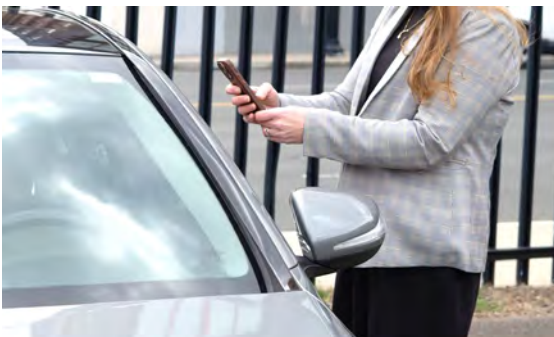
Step 1: See the Sticker

Step 4: Remove the Sticker

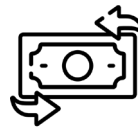
