WAREHOUSING

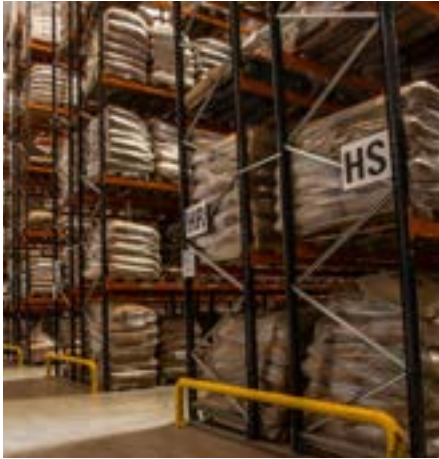
Warehousing is our core activity and has been the cornerstone of our organisation for 35 years. Across 2,500,000 square feet of mixed storage we offer bonded, bulk, racked and temperature controlled solutions.

Our warehousing is multi accredited, with the UK holding BRC 'AA+' certification. Our certifications include an Intercontinental Exchange (ICE) licence to store coffee and cocoa, New York Stock Exchange (NYSE) for arabica coffee and a London Metal Exchange (LME) licence to store metals. We are also Organic Certified in both the UK (OFF) and Antwerp (TUV NORD) and hold Rainforest Accreditation in the UK for Warehouse & Distribution.



Ambient Storage

Ambient pallet storage is available in our UK warehousing facilities - ideal for all bagged or boxed products. The ambient environment provides a stable temperature and humidity level.



Bulk Bag Storage

Bulk bags containing raw food ingredients are stored in our warehousing facilities in UK and Europe. We have the facilities to store bulk bags on floor pallets and on racking, depending on location.



Bulk Pile Storage

Our state-of-the-art 66,000 m² mega bulk quayside terminal in the port of Amsterdam incorporates our commodity warehousing expertise with the latest technology to protect the quality of cocoa beans.



Temperature Controlled Storage

This storage facility is maintained at 10-11°C to preserve the quality of perishable items such as dried fruit, nuts & some organic products. By storing these items off the floor, we reduce exposure to contaminants, while ensuring proper air circulation around products.



Metals Storage

Our metals division, Erus Metals, is a fully registered Warehousing company with the London Metal Exchange. We specialise in metal storage as well as stock control, LME warranting and the provision of solutions to your metal warehousing needs.



Bonded Storage

A number of our warehouses in Europe are licensed for bonded storage of soft commodities, metals and other cargo. If you need space to store goods to delay the payment of customs duties and taxes until the goods are released from the warehouse, please contact us.

Jute Bags

Jute bags play a crucial role in the food storage process within the soft commodity supply chain, in particular for products that we specialise in such as coffee, grains and pulses. Jute is biodegradable and sustainable, making it an environmentally responsible choice in the food industry - something we value highly.



FIBC / Bulk Bags

Bulk bags, also known as Flexible Intermediate Bulk Containers, are essential tools in the storage and transportation of soft commodities. Their large capacity helps to optimise storage space and enabling efficient handling and transport. The versatility and reusability of bulk bags also make them a cost-effective and environmentally friendly option.



Loose Bulk

Handling loose, bulk soft commodities, such as cocoa beans, requires careful attention to ensure product quality and prevent contamination. Cocoa beans are handled and stored using custom equipment and processes to protect them from damage, moisture and pests. We ensure the beans reach their destination in optimal condition for processing.



Boxes & Cartons

In the food industry, the proper storage of boxes and cartons is vital to prevent damage to packaging and the products inside. Boxes and cartons are kept in dry, clean and well-ventilated areas to protect against moisture, pests and contamination. Our effective storage systems, such as shelving units and palletised stacking, help ensure that your products are well organised and their quality is maintained at all times.



Stevedoring

We manage multiple quayside Stevedore activities in both our Belgium and Netherlands facilities. In Antwerp we operate over three different quays which can accept vessels from barges to coasters and mega bulk vessels. In Amsterdam we operate a single quay adjacent to our market leading cocoa terminal allowing efficient unloading of cocoa beans into the warehouse.

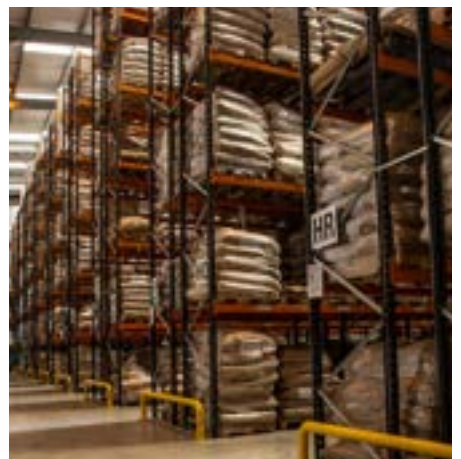

The development of this bespoke 66,000 sqm terminal and megabulk quay, sees the incorporation of our commodity warehousing expertise along with the latest technology, culminating in a market leading offering where the purpose is to ultimately protect the quality of the product.

The design of the terminal allows for maximum efficiency as beans are moved from the container pit directly to the warehouses via belts for containers and direct from the vessel to the pen for mega bulk.

Barge loading is also completed using high capacity belts direct from the warehouse to the barges. This allows bulk carrier trucks to be loaded in any weather condition without entering the warehouse.

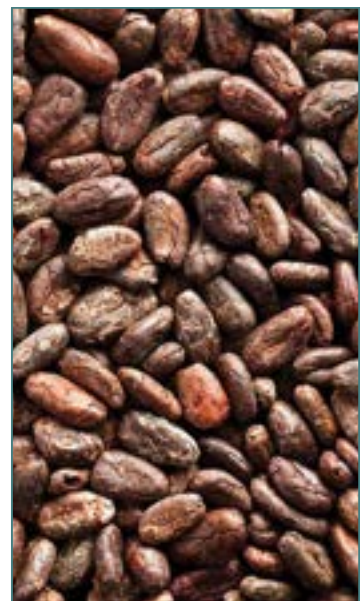
