(Business Identification Number 0219010171526) (**Bumi Resources**), gives notice under section 630(3) of the Corporations Act 2001 (Cth) (**Corporations Act**) in respect of its offer dated 8 August 2025 to acquire all of the fully paid ordinary shares in Wolfram Limited ACN 660 853 814 (**Wolfram**) under Chapter 6 of the Corporations Act (**Offer**). - (b) all defeating conditions have been fulfilled or waived under section 650F(1) of the Corporations Act, and the Offers are now unconditional; and
- (c) Bumi Australia's voting power in Wolfram is 91.81%.
