DUE TO THE COVID-19 PANDEMIC, THE ORGANIZATION EXPERIENCED A TWO-YEAR INTERRUPTION OF SERVICES. THE IMPACT OF THE PANDEMIC WAS MORE ACUTELY FELT BY OUR CAMPERS WHO ARE CHILDREN WITH DISABILITIES OR LIFELONG ILLNESSES. CCK BEGAN TO RESUME ITS CAMPS IN 2022 AND IS CONTINUING TO INCREASE SERVICES TO THESE CHILDREN. IN 2025, THERE WERE 853 CAMPERS WHO WERE ABLE TO ENJOY OUR TRANSFORMATIVE CAMP PROGRAMS AT NO COST TO THE CAMPERS OR THEIR FAMILIES. THIS NUMBER WAS UP FROM 781 CAMPERS IN 2024. AN INCREASE OF MORE THAN NINE PERCENT.

IN ADDITION TO THE INCREASE IN SERVICES, CCK WAS THE 2024 RECIPIENT OF THE .ORG IMPACT AWARD FOR DIVERSITY, EQUITY, AND INCLUSION. THE ORGANIZATION WAS SELECTED AS ONE OF THE 35 FINALISTS OUT OF 1,700 APPLICANTS FROM MORE THAN 87 COUNTRIES.

SINCE CCK DOES NOT CHARGE FOR ITS SERVICES, IT IS ALMOST EXCLUSIVELY RELIANT ON DONATIONS. IN 2025, THE ORGANIZATION HIRED A NEW VICE PRESIDENT OF DEVELOPMENT. THIS INDIVIDUAL OVERSEES DEVELOPMENT EFFORTS, INCLUDING DONOR RELATIONS, FUNDRAISING STRATEGY, AND COMMUNITY PARTNERSHIPS. WORKING
