# Benton REA Academic Scholarship Program 2025-2026 School Year

## Provisions for Academic Scholarship

### I Eligible Candidates

All children of Benton REA members, or members themselves, are eligible candidates; excluding any person serving on the Selection Committee, any Benton REA employee, or any Benton REA board member, or the children of any of these excluded individuals. Part-time Benton REA student employees are not included under the "Benton REA employee" exclusion.

### II Student Qualification Conditions

- A. At the time of initial application, the candidate must be a graduating high school senior.
- B. Applicant must be enrolled or planning to enroll in an accredited college, university, or training institution.
- C. The candidate may be enrolled in any field of study.
- D. A candidate may use a scholarship at any accredited college, university or training institution that leads to an undergraduate bachelor's degree.
- E. Parent(s) or legal guardian(s) of the candidate, or the candidate, must be a member of Benton REA with the member's primary residence located within Benton, Yakima, or Lewis counties.
- F. Recipients agree to participate in the next Association annual meeting. If the scholarship recipient is unable to attend the annual meeting, they must make acceptable alternative arrangements with the manager of Community Development and Member Relations, or his/her designee.
- G. The recipient must have completed all requirements necessary to be fully matriculated at the beginning of the term.

### III Application Procedures

- A. Applicants for academic scholarships must complete an application form, a description of involvement, submit a 500-word typewritten essay,\* and include a copy of their high school transcript. **Submission of SAT or ACT scores is currently being waived.**

\* If any information, facts, or ideas from other sources (even if paraphrased) is used, sources **must be cited in a bibliography** listed on page two of the scholarship application.

- B. All applications for the annual scholarship must be received prior to the deadline for submitting the application and essay.

### IV Selection Criteria

- A. General Selection Criteria will include the following considerations:
  - 1. Meet all eligibility requirements.
  - 2. Submission of 500-word essay with bibliography, as assigned.
  - 3. Grade Point Average. A copy of the applicant's transcript must be provided.
  - 4. Description of student's school involvement, extra-curricular activities, hobbies, special interests and/or talents, including information showing the level of involvement in school, leadership skills, and concern or support of the community. Supporting materials are encouraged, such as certificates, pictures, and videos.
- B. The following point scale will be utilized for determining the five recipients of the annual scholarship funds:

## **V Limitations**

- A. Scholarships will be awarded for one (1) school year at a time.
- B. Scholarships will be paid directly to the recipient's college, university, or training institute of choice upon Benton REA's receipt of appropriate evidence that the recipient has been accepted as a full-time student.
- C. First priority use of Academic Scholarship funds must be to pay tuition. If money remains after tuition is paid, the candidate may purchase books and submit documented receipts to the Benton REA Review Committee to obtain reimbursement of such expense. Clothing, transportation, appliances, telephones, and food do not qualify for payment.
- D. Unused scholarship funds will be retained by Benton REA. Unused funds may result if a student is over financed or if a recipient ceases to be a student. Scholarship funds that have been sent to a college or university that are not used by a qualifying recipient shall be refunded to Benton REA, not to the student.
- E. Scholarships are not assignable.
- F. Recipients of a continuing education scholarship must maintain an annual cumulative GPA of 3.0 or higher to remain in the program. The student must provide Benton REA with a **certified** transcript of their GPA from the school by August 1<sup>st</sup> of each year. If the recipient's annual cumulative GPA is below 3.0 but higher than 2.75, the recipient may apply to the Association requesting the scholarship be reinstated if the recipient remains enrolled as a full-time student and maintains a GPA of 3.0 or higher in all the grading periods for the subsequent school year. Application for reinstatement must be in written form with the GPA requirements verified by a certified transcript from the educational institution. The ability to apply for reinstatement expires 13 months following Benton REA's receipt of the certified transcript in which the initial annual cumulative GPA requirements were not met. The reinstatement provisions within this section shall not change, or modify the intent of, any of the other provisions in this policy.
- G. Access to the scholarship fund for an academic scholarship is valid for a limited time, not to exceed six (6) years from the date of initial enrollment in an accredited college, university or training institution and the funds shall only be disbursed for a period not to exceed four (4) school years. Academic scholarships are to be paid out at \$2,000 for each school year, subject to listed provisions to assist successful academic scholarship applicants with earning an undergraduate bachelor's degree. Academic scholarship recipients can attend a community college and transfer to a university as they work towards earning an undergraduate bachelor's degree. If a scholarship recipient provides a schedule that verifies the recipient will complete an undergraduate bachelor's degree program in less than four school years, as determined by the Benton REA Review Committee, all remaining funds of the \$8,000 scholarship will be paid in the final year.
- H. Continuing access to scholarship funds is contingent upon the parent(s) or legal guardian(s) continuing their membership with Benton REA with their primary residence located within Benton County, Lewis County, or Yakima County.
