



LNG Net import by region (MT)




Top Variations 2024 vs 2023 (MT)





Monthly Utilization rate of regasification capacity



 - Ensure consistency with EU Methane Regulation.


MRV Framework (2/3)

V1 pathways




MRV Framework (3/3)

V2 pathways




