The Company disposed of 77,399,381 shares of treasury stock through a third-party allotment on May 20, 2024 based on resolutions of Extraordinary General Meeting of Shareholders on May 9, 2024. Accordingly, the capital surplus increased by 26,238 million yen and the treasury stock decreased by 23,761 million yen. As a result, the balances of capital surplus and treasury stock as of June 30, 2024 were 437,323 million yen and 174,006 million yen respectively.
