Three Take-Aways

1) **Trump-Xi trade deal yields agreements on soybeans, lower Fentanyl related tariffs, delay in rare earth curbs and roll back in port fees. Sentiments muted as lofty expectations were not met.**

2) **ECB held rates as Lagarde retains good place narrative. BoJ's cautious approach to rate hike set back the JPY.**

3) **Taiwan Q3 GDP to be buoyant on semiconductor cycle but EM-Asia may begin to ponder their near term trade tailwinds as lower China tariffs may see lesser trade diversion.**

MACRO THEME: Amazing, But Not Surprising?

- While US President Trump said that he had an amazing meeting with Chinese President Xi which ranks 12 on a scale from 1 to 10, the **lofty build-up in expectations meant that the market response being somewhat muted is not too surprising.**

- There was progress on the tariff front with the **Fentanyl related tariffs being lowered to 10% from 20%.** As for China, they will be resuming soybean purchase and pause their rare earths licensing regime for a year. On soybeans, it is said that the agreed minimum of 12m tons of soybeans for this season and minimum of 25m tons annually for the next three years is **restoration to normal** levels, competition from Brazil and Argentina imply that these targets may not be as easy or economically efficient to achieve. Reciprocal port fees have also been suspended for a year.

- Meanwhile, the lack of progress on aspects such as Blackwell chips and Tiktok deal may have dented sentiments.

- Looking ahead, the deal is likely to be negotiated annually though extensions are said to be par for the course. While the lowering of tariffs may imply mitigated inflationary fears, the extended clarity from these deals may marginally embolden growth to give dovish Fed bets some caution. That said, **US government shutdown enters Day 30 with little clarity on a potential end** while industries such as travel are increasingly concerned.

ECB: Good Places, Rotating Seats?

- The ECB kept rates unchanged with ECB President Lagarde saying that **they are in a good place** and their inflation outlook remains broadly unchanged. Admittedly, with EZ GDP growth also outperforming last night and the ECB maintaining a broadly unchanged inflation outlook, the situation is not too bad for now. Furthermore, amid divergence within EZ growth (French outperformance, German and Italian stagnation) juxtaposed against their fiscal situation, aggregate EZ growth may remain in such a place for longer. As such, while external downside risks may have been mitigated, **intra-EZ differences** also imply that outright booms and bursts may also be tempered.

BoJ: Cautious Approach to Rate Hikes

- The **BoJ stood pat with the same two dissenters** preferring a hike to 0.75%. An upgrade of their GDP projections alongside an allusion to underlying inflation being likely to increase gradually continue to affirm them edging towards a rate hike.

- Nonetheless, **Governor Ueda continue to sound cautious** as he wants to examine the result of wage negotiations for next year but also said that he need not wait till final wage talk results.

In terms of fiscal/political considerations, he alluded to the possibility of raising rates during budget formulation. On balance, the dovish tones sent USD/JPY higher to test mid-154.

- USD gained against all G10 peers amid higher UST yields.

- EUR slipped towards mid1.15 while AUD dropped to mid 65 cent. USD/SGD rose to above 1.30 and EM-Asia FX look set to be on the back foot to end the week.

EM-Asia: The Cautious Optimism

- Undoubtedly, easing US-China tensions is a positive for EM-Asia and the 1 year truce provides better sight relative to previous 90 day truce.

- That said, the **lowering of Fentanyl tariffs to 10% implies that US tariffs on Chinese goods is now level with most trading partners in Asia** aside from Korea and Japan which have secured the 15% rate via their huge investment deals.

- Accordingly, near term **need for trade diversion or production allocation changes across the region may be dampened.** This will impact ASEAN countries which has enjoyed substantial external demand tailwinds. Accordingly, ASEAN FX came come under renewed pressures with added drag from a recovery of oil prices from mid-Oct lows.

Taiwan Q3 GDP: Elevated

- In Taiwan, we expect a very robust print for Q3 GDP growth of 7.1% YoY though it will be an inevitable slowdown from Q2's 8.0% YoY. Consequently, we upgraded full year 2025 forecast to 6.6% and ensuing momentum also implies an upgrade to 2026 growth estimate to 2.9%.

- Amid the strong semiconductor cycle, the export demand boost remains very apparent in Q3 with exports (customs basis) growing 25.7% YoY in Q3 which represents a 5.2% QoQ expansion.

- Similarly, this was evident in buoyant wholesale trade figures amid strong shipments of AI servers and electronic components. Nonetheless there were multiple soft spots as wholesales of automobiles, chemicals and fabrics declined across the board.

- **Domestic consumption also remains cautious** with retail sales contracting 1.8% YoY in Q3 as poor demand for luxury goods and automobiles reflecting subdued consumer confidence. Residential property prices growth has also stabilised, albeit with prices at elevated levels while loans to the real estate sector have also plateaued.

- All in, this growth print adds to the case that there is little need for the CBC to ease policy settings in the near term even though the lower CPI prints certainly provides ample scope for easing in 2026 should the semiconductor cycle show signs of weakening.

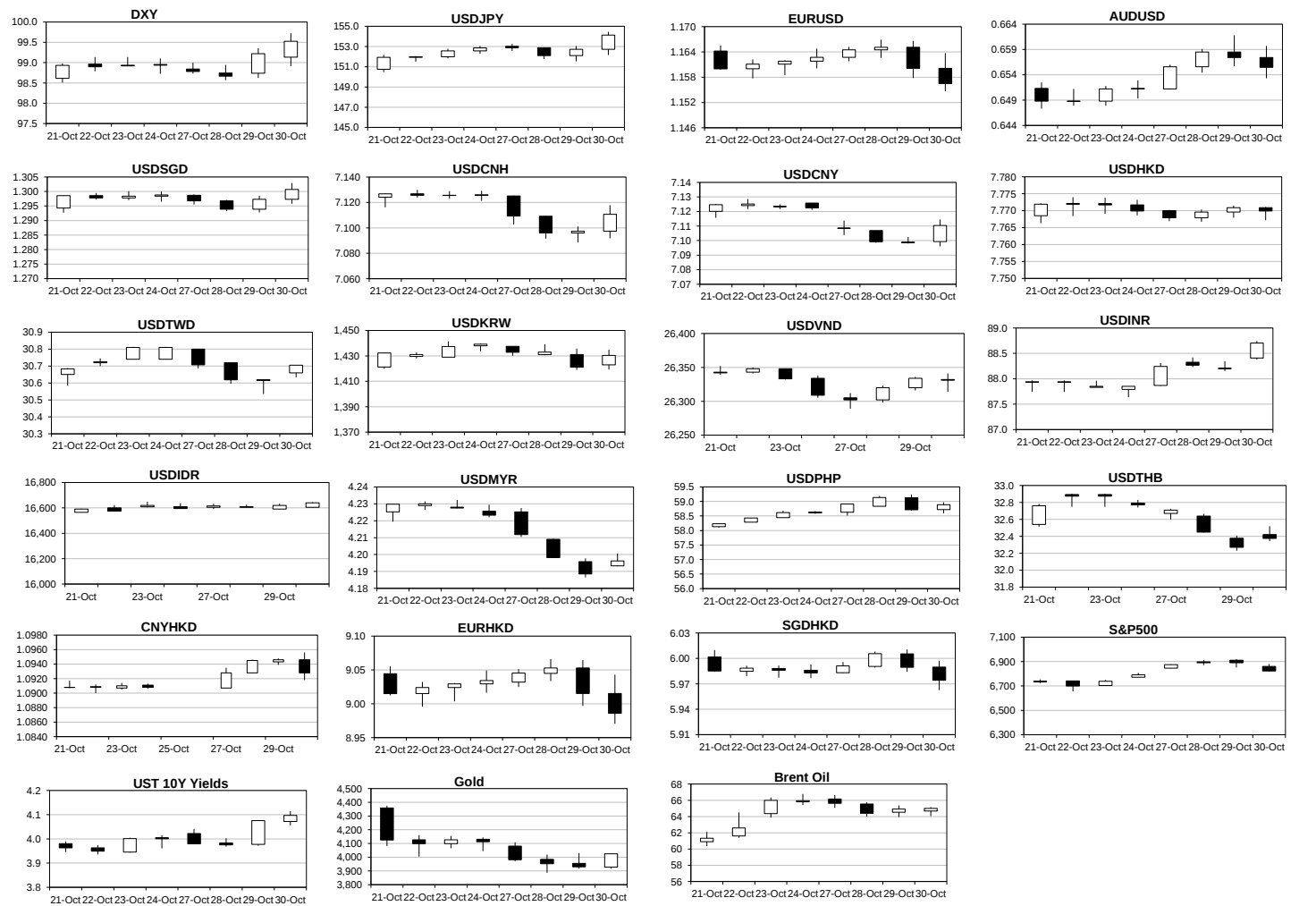
