**Three Take-Aways**

- 1) **Rising energy prices are reigniting concerns over a more hawkish Fed response.**
- 2) **A faster BoJ path may slow yen weakness, but structural pressures mean hints alone are unlikely to reverse USD/JPY.**
- 3) **ECB is expected to hold, but Lagarde is likely to retain a hawkish, meeting-by-meeting stance.**

**MACRO THEME: Energy Shock Reignites Hike Fears**

- Risk sentiment remained under pressure overnight as the **US-Iran conflict entered its 12th day**, with both sides showing little willingness to de-escalate.

- Meanwhile, **Yemen's Houthis announced an embargo on Saudi oil exports through the Bab el-Mandeb Strait**, raising concerns that disruption risks are now spreading across the Red Sea that adds further pressure to global supply chains. The market response was most visible in energy markets. **Brent crude climbed 3.4% to US\$94.07/bbl** on the day.

- US rates moved sharply higher as investors repriced the inflation outlook. The **2-year Treasury yield rose to 4.30%**, its highest since 13 Feb. 2025, while the **10-year yield climbed to 4.66%**.

- The front end continues to lead the move as markets increasingly question whether the Fed can maintain a prolonged pause should elevated oil prices begin feeding into headline inflation.

- While a July hold remains the base case, the balance of **risks has shifted in a more hawkish direction**, with markets becoming more sensitive to further energy-driven upside surprises in inflation.

**JPY Needs More Than Hints**

- JPY remained under pressure overnight despite **reports that BoJ officials are open to raising rates faster than the market's assumed pace** of roughly one hike every six months.

- That said, the BOJ is still widely expected to keep rates unchanged at 1.0% at the 31 July meeting, but the report shifts attention to subsequent meetings, with **September and October now looking more "live"** if yen weakness and cost-driven inflation pressures persist.

- **The market reaction was limited.** USD/JPY briefly eased from its session high of 163.24 to around 162.69, but the move lacked follow-through and the pair ended Wednesday little changed near **163.15**.

- **The key issue is that yen weakness remains structural.** Japan's persistent trade deficit, higher energy import bill, fiscal concerns and still-wide US-Japan rate differential continue to weigh on the currency.

- **A faster BOJ cycle may help slow yen depreciation at the margin**, but unless the BoJ signals a more forceful tightening path, incremental hikes are unlikely to engineer a sustained reversal in USD/JPY.

**ECB Preview: Holding with Hawkish Intentions**

- **A rate hold by the ECB remains the expected outcome** of the upcoming meeting though the **upside risk to inflation** from a resumption of US blockade of the Strait of Hormuz implies that the signal of continued vigilance will be strong one.

- Specifically, gas prices in Europe which saw no relief even after the MoU has risen at an even faster pace following the renewed hostilities in the US-Iran war. **Gas prices in Europe are 65% higher relative to pre-Iran war levels** while Brent crude prices are up just 15%.

- Furthermore, with wheat prices edging higher on escalation in conflict between Ukraine and Russia, pipeline food inflation remains worrying especially as fertiliser woes compound.

- Even amid these intensifying risks, it should be noted that Eurozone growth remains far weaker compared to the hiking cycle in 2022-23.

- As such, a measured and cautious to inflation pressures remains optimal with **ECB President Lagarde likely to refrain from forward guidance** in alignment with Council Member and Bundesbank President Nagel who espoused a meeting-to-meeting approach.

- Accordingly, **EUR bulls may find little relief** from this decision as supply chain disruptions and energy dependencies impose much harsher economic constraints compared to the US.

**Red Sea Blockade: A New Supply Shock Risk**

- While the Houthis blockade threat is formally aimed at **Saudi Arabia** rather than the Red Sea as a whole, markets are likely to price a broader disruption risk. The Bab el-Mandeb Strait connects the Red Sea to the Gulf of Aden and is a **key chokepoint** for the Suez Canal route, carrying roughly **one-quarter of global container flows and around 12% of seaborne oil trade**.

- The timing is particularly concerning. With the US-Iran conflict already disrupting shipping through the Strait of Hormuz, the Red Sea has become an increasingly important alternative route for regional energy exports. Saudi Arabia, in particular, relies heavily on this corridor, leaving **up to 2.5 million barrels per day of oil exports exposed to disruption** if Red Sea tensions escalate further.

- That said, the immediate risk is not necessarily a loss of physical supply but a **rise in transportation costs**. As seen during previous Red Sea disruptions, **shipping lines may bypass the Suez Canal-Red Sea corridor and reroute around the Cape of Good Hope** at the southern tip of Africa. Such detours extend transit times between Asia and Europe, increase fuel and insurance costs, and reduce effective shipping capacity. The resulting supply-chain friction would **tighten logistics conditions** even if underlying trade volumes remain largely unchanged.

- The development could **reinforce the non-linear rise in energy prices already underway** after the resurgence of the US-Iran conflict. If sustained, renewed inflation pressure **could push central banks toward a more hawkish bias**. Unless tensions de-escalate, the Red Sea blockade threat remains a material upside risk to inflation, policy uncertainty and global market volatility.

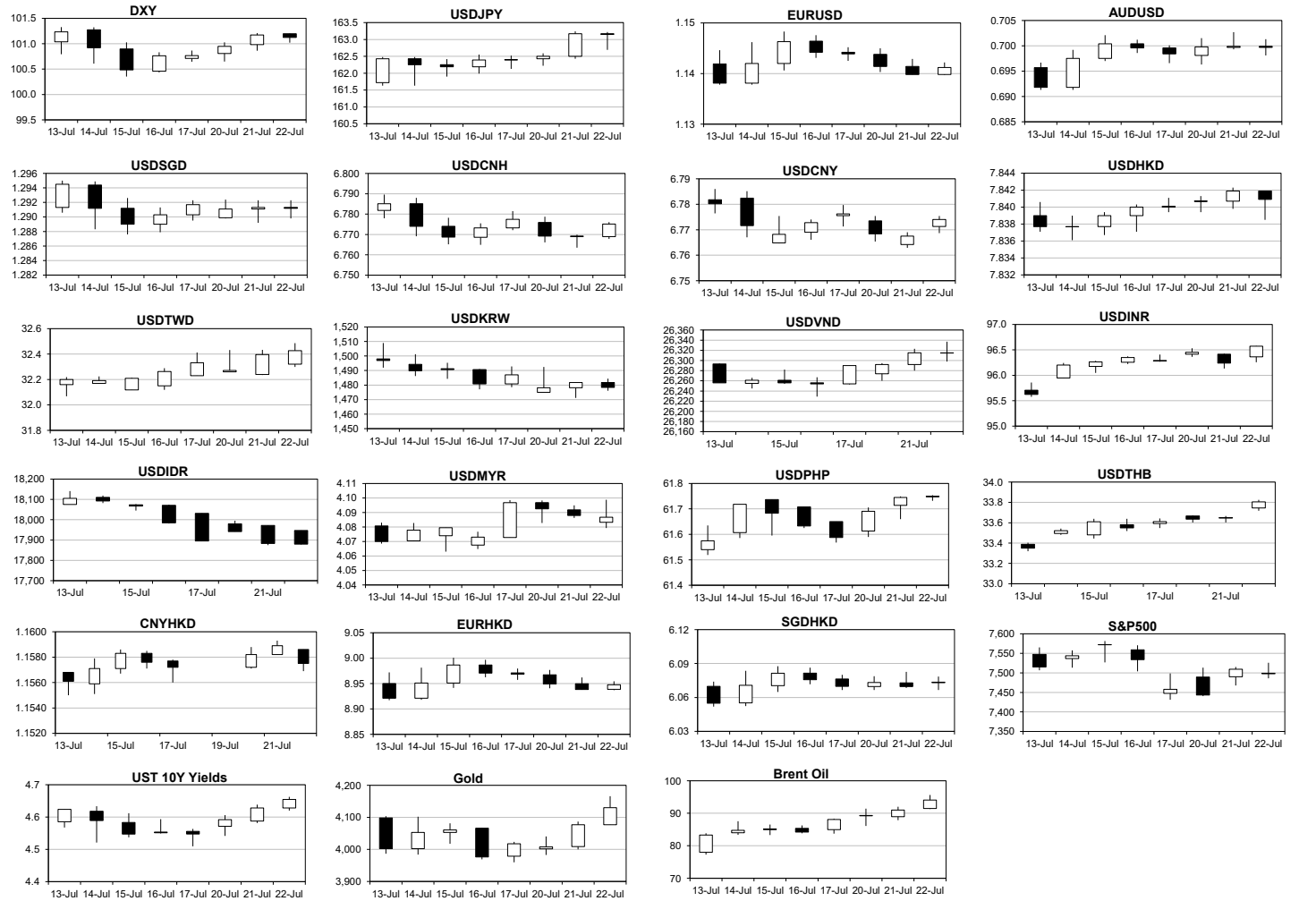
