Avoiding Contamination

Avoid missed pickups by reviewing your programs every year and following the program check lists below.

Set Up Disposal Area for Success

- ✓ There is a compost & recycling container next to each landfill container both inside and outside.
- ✓ Containers have proper labels and additional signage is near the containers.
- ✓ The waste area is clean and well maintained, and containers are not damaged or vandalized.

Make it Easy for All Employees / Customers to Compost & Recycle

- ✓ All recycle and compost carts are clearly labeled.
- ✓ There is signage on materials accepted in the recycling and compost visible from the containers.
- ✓ All employees have received compost & recycling information in the past 12 months.
- ✓ Customers have access to properly labeled recycling, garbage, and compost containers.
- ✓ Containers are periodically inspected for contamination, and employees are regularly reminded on proper sorting procedures.



When to Make Adjustments

- There are recyclables (i.e.: metal, clean paper) or compost (i.e. food, soiled paper) in the landfill container.
- There is landfill (i.e. plastic bags, dog/cat waste) in the recycle and/or compost container.
- The recycle and/or compost containers are full before collection.
- The landfill container is less than 75% full before it is picked up.

If any of the these apply you may need to increase your on-site training and/or change your service levels. For help with on-site training and to make any service level changes call AVI at 925-479-9545.
