

Events & MCT CPT Codes

Quick Guide

Event Monitoring & Mobile Cardiac Telemetry (MCT) is fully covered by Medicare. Federal and private insurance plans also cover Event Monitoring, though MCT may require prior authorization.

Below are the codes you will need to use when billing for Cardiac Monitoring Services.

Event Monitoring

These are typically worn between 2–4 weeks and captures data when a patient activates the device upon feeling symptoms.

Mobile Cardiac Telemetry (MCT)

MCT provides near real time monitoring. The cardiac rhythm is recorded and monitored continuously so if an arrhythmia is detected, the physician is notified within minutes.* This monitoring is not covered by all plans and may require authorization.

* While patient is in cell phone range. Device will store all data until patient is back in range.

Billing options under the Medicare CPT Codes
