Resource Libraries


The module allows you to create or import a Resource Library structured into three levels:

- Primary Level (1-9): Reflects major cost groups such as Plant, Labour, and Materials.
- Subdivision Level (A-Z): Further categorises resources, such as skilled vs. unskilled labour or different material types.
- Detailed Level: Additional breakdowns for greater precision if required



MasterBill & BOQ Importing

- MasterBills define recurring items used for rapid pricing, such as sand and cement or bricklayers and bricks.
- Bills of Quantities can be imported from WINQS, Bill, or Excel, ensuring compatibility with various formats.
- Pricing can be conducted at any level of detail, providing full flexibility.



Tenders & Analysis

- Tenders can be analysed across multiple dimensions, such as cost centers, Pareto analysis, or by resource type.
- Custom reports can be defined and exported as Excel or PDF files—ready for emailing or WhatsApp sharing

Project Scheduling

- A Gantt Chart tool, similar to MS Project, enables sequencing of events, specifying durations, and setting deadlines.
- BOQs can be linked to the schedule to generate cash flow and resource demand reports over time.
- Multiple bill items can be linked to a single activity for precise tracking.



Cash Flow & Resource Planning

- Generates lifetime cash flow projection diagrams, factoring in cost prices, retention, and selling prices.
- Estimates and schedules are fully linked, providing resource requirement forecasting over specified intervals

Progress Tracking & Certificates



Flexible data-entry

Track and manage project progress with flexible data entry options:

- Cumulative units, with the system automatically calculating monthly progress.
- Monthly units, with cumulative progress tracked in real time.
- Cumulative percentage completion, ensuring accurate project valuations.
- Worksheet entry, allowing for custom arithmetic functions and adjustments.



Progress certification & valuation
