It is necessary for your local Community Games Area to collect and record certain personal data relating to each participant including – the participant’s name, address and date of birth. We also require the telephone number and email address of their parents/guardians (if under 16).

The data pertaining to each participant will be used for management and administration purposes only and will be input onto National Community Games’ secure Online Registration System (www.communitygames.info) and any other third parties to facilitate any service provided by your Area (for example: group email services such as Mailchimp or group messaging services such as Whatsapp, Viber and BulkText).

Any persons receiving the information shall not use it for commercial purposes or release it to any party without prior approval and shall ensure that all devices with your data on it are secured by password and/or encrypted.

Community Games has a Photography and Filming Policy in place www.cairncommunitygames.ie/volunteers/policies and reserves the right (in line with this policy and our Child Protection Policy) to publish game/match/race reports and any related imagery including photographs and videos of each participant either in team or individual events in local or national print or electronic media. We always seek individual consent if any of those images are chosen for campaigns with our title sponsor.

Where a Parents wishes to withdraw consent having previously given permission the parent/guardian **MUST** notify their Area Secretary in writing and Area Secretary must notify the County, Provincial and National organisers in advance of the event, so that all levels are aware and appropriate measures can be put in place

In accordance with our child protection policy, photographs, video or other images of young people should not be taken without consent. If the child is under 18, consent must be obtained from a parent/guardian.

Community Games recommends that parents/guardians speak to their child about image consent and respect their choice in the use of their image.

Where Consent Is Not Given

If a parent/guardian does not give consent for their child to be photographed or recorded:

The parent/guardian **MUST** notify their Area Secretary via this Parental Consent Form and Area Secretary must notify the County, Provincial and National organisers in advance of the event, so that all levels are aware and appropriate measures can be put in place.

Parents/guardians are responsible for ensuring that their child does not participate in group photos, including team shots, parade shots, opening or closing ceremony photos, or podium/medal presentations where images are routinely taken.

Parents must also ensure that their child does not step into team line-ups, victory photos, or social media content areas during the event.

While every reasonable effort will be made by Community Games volunteers, officials and contracted photographers to respect a parent’s decision not to consent, some events are live-streamed, and crowds or busy environments mean it may not always be possible to completely avoid incidental capture of individuals in wide-angle or crowd shots. Parents/guardians should be aware that full exclusion cannot be guaranteed in these circumstances, and therefore it is essential that they inform their children of the limits of non-consent. Notices will be put at events to remind parents that photographs/videos are being taken. Parents may make themselves know to officials if they do not wish to have them or their children recorded.
