

CourseHopper Terms of Use

Effective Date: April 7, 2025

Welcome to CourseHopper! These Terms of Use ("Terms") govern your use of our website(s) including but not limited to course-hopper.webflow.io and any affiliated domains, mobile applications, membership services, and any related content or features (collectively, the "Services"). By accessing or using the Services, you agree to be bound by these Terms.

1. Membership Eligibility

To purchase a CourseHopper pass or join the waitlist, you must be at least 18 years of age and provide accurate, complete, and current information. We reserve the right to limit the number of memberships sold in order to maintain a healthy ratio of members to partner courses.

2. Use of Services

You agree not to:

- Use our Services for any unlawful purpose.
- Access or tamper with non-public areas of the platform.
- Misrepresent your identity or use another person's membership.
- Attempt to manipulate or abuse the redemption system.

3. Membership Terms

CourseHopper offers limited golf access passes that grant access to rounds at participating public golf courses. Memberships are non-transferable and non-refundable unless otherwise stated. Pass holders may only redeem tee times under the terms associated with their specific membership tier. CourseHopper is not responsible for availability, closures, or blackout dates enforced by partner courses.

4. Redemption Limitations

Each pass includes a set number of allowed redemptions per season. **Members are limited to one redemption per day.** Rounds are not transferable, and unused rounds do not roll over to the next year. CourseHopper reserves the right to limit daily or monthly redemptions to ensure fair access for all members. Members' maximum redemptions rely purely on how many courses we are partnered with at any given time. For example, if there are 20 courses, then each member has a max of 40 redemptions. If they want to play any course a third time, they can do so at the standard course rate, which must be paid directly to the course itself.

5. Partner Courses

Participating courses are subject to change. CourseHopper works with independently operated courses, which retain full control over tee time availability, scheduling, and operating hours.

6. Intellectual Property

All logos, branding, images, and original content on this site are property of CourseHopper and may not be copied or used without written permission.

7. Limitation of Liability

CourseHopper is not liable for any injuries, damages, or losses sustained while using a participating golf facility. You acknowledge that your use of the Services is at your own risk.

8. Privacy

Your use of the Services is also governed by our Privacy Policy, which describes how we collect and use your information.

9. Modifications to Terms

We may update these Terms at any time. Your continued use of the Services after any changes constitutes your acceptance of the new Terms.

11. No Guarantee of Availability

CourseHopper does not guarantee tee time availability at any partner course. All redemptions are subject to availability and course discretion. Blackout dates, maintenance closures, weather conditions, and course policies may affect access.

12. Redemption Rules Enforcement

Members who attempt to circumvent redemption limits, book fraudulent tee times, or misuse their membership may have their account suspended or terminated without refund. CourseHopper reserves the right to audit redemptions for suspicious behavior.

13. Non-Refundable Memberships

All membership purchases are final. Refunds will not be issued for unused rounds, course closures, personal scheduling conflicts, or changes to the partner course list.

14. Changes to Partner Courses

CourseHopper reserves the right to add or remove partner courses at any time. While we strive to maintain a robust and diverse list, participation is at the discretion of each course and may change without notice.

15. Technology Disclaimer

CourseHopper relies on third-party platforms and integrations for booking and redemption services. While we work to maintain stable and secure systems, we are not liable for temporary outages, technical failures, or delays in redemption tracking.

16. Payment Security

All payments are securely processed through third-party providers. We do not store or manage your credit card information directly.

17. Cart Fees

Unless explicitly stated otherwise, CourseHopper memberships do not include golf cart rentals. Cart fees are the responsibility of the member and are paid directly to the course at the time of play. The only exception is when a course has a cart fee built into their standard posted rate, in which case the cart may be included.

18. Member Code of Conduct

All CourseHopper members are expected to behave in a respectful and sportsmanlike manner at all participating golf courses. This includes following all course rules and policies, treating staff and fellow golfers with courtesy, and maintaining proper pace of play and etiquette. Members who are reported for misconduct, repeated rule violations, abuse of course property, or disruptive behavior may be subject to suspension or termination of their membership at CourseHopper's sole discretion. No refunds will be issued in such cases.

19. No-Show and Late Fees

Members may be charged a fee for failing to show up for a booked tee time ("No-Show Fee") or for arriving late and affecting the course schedule ("Late Fee"). Fees vary based on the partner course and are payable directly to the course. Repeated no-shows or late arrivals may result in suspension or termination of membership without refund.
