

SUMMARY ANNUAL REPORT

For Pixar Group Health And Welfare Plan

This is a summary of the annual report of the Pixar Group Health And Welfare Plan, EIN 68-0086179, Plan No. 501, for period 08/01/2023 through 07/31/2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Pixar has committed itself to pay certain self-insured Medical, Dental, Vision, and Short-term Disability claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with Kaiser Foundation Health Plan, Inc., Modern Health Arizona, Pllc, Metlife Legal Plans and Life Insurance Company Of North America to pay Medical, Life Insurance, Long-term Disability, Accidental Death and Dismemberment, Employee Assistance Program, and Legal claims incurred under the terms of the plan. The total premiums paid for the plan year ending 07/31/2024 were \$4,183,658.
