Chad Weichel reviewed the water committee minutes from December 9th.

The revised Motion #5 upon Amendment #1 would read: to lift the moratorium on the expansion of irrigated acres in sub areas 1, 4 and 5, effective January 1, 2026. Amendment Carried.

WATER WELL PERMITS, IRRIGATION AGREEMENTS

Staff reviewed a well registration form being submitted to the Nebraska Department of Water, Energy, and Environment (DWEE) by Heartland Bank. The well was drilled in the early 1990s and is the source well for irrigating 123.39 certified acres in the SE ¼ of Section 4-Township 2N-Range 5E in Gage County. These are brought before the Board since one of the required components of the registration form is a NRD signature verifying the well was drilled prior to stays or moratoriums.

MOTION #6 was made by Larry Barta, seconded by Chad Weichel to recognize that the well was drilled prior to any stays or moratorium. Motion Carried.

BUILDING COMMITTEE REPORT

Dean reviewed the minutes of the November 25th meeting. Part of the parking lot has been poured. The contractor has put plastic on the door and window openings and plans to heat the building to prep for interior cement work. The next meeting is scheduled for Monday, December 29th at 10:00 a.m. at the NRD Office.

PROGRAMS AND PROJECTS COMMITTEE REPORT

Ryan Birkett reviewed the minutes of the December 8th meeting. Staff reviewed discussions with Tallgrass Energy regarding the consent to cross agreements of NRD flood control easement by the proposed pipeline.

Scott T. discussed the slip-lining project at Plum 4A. This structure was built in 1966 and has a drainage area of 1.87 miles. Scott presented estimates for repair of the principal spillway. Estimates to complete a cast-in-place liner is approximately \$30,000 more than the estimated cost of NRD staff to install a Snap-Tite liner. The landowner has agreed to pay half of the additional cost of the cast-in-place liner to avoid draining the lake and keep the fishery intact. The landowner has requested to enter a multi-year contract to reimburse the district. The Committee recommended reducing the proposed length of the reimbursement period.

MOTION #7 was made by Dean Roehr, seconded by Chad Weichel, to approve the cast in place quote of \$67,315 and approve repayment of the landowner share of \$15,150.85 over a 3 year

period contingent upon erosion repair and fence improvements to control cattle access. Motion Carried.

Scott S. reviewed a Wild Nebraska Wildlife Habitat cost share agreement that includes seven acres of native grassland enhancement for the benefit of quail. The total estimated cost of the project is \$1,050.00 with 50% cost share in the amount of \$525.00 from the Nebraska Game and Parks Commission and 25% percent or \$262.50 from the NRD. The landowner is responsible for the balance.

MOTION #8 was made by Larry Barta, seconded by Dean Roehr, to approve the WILD Nebraska agreement. Motion Carried.

Scott S. informed the committee that BCH has asked the NRD for approximately 600 yards of sediment from Clatonia Public Use Area for the construction of a Hospital Cancer Garden. Clatonia lake is currently dry due to the extended drought in the area and the hospital has volunteers to load and haul the material.

MOTION #5 was made by Steve Kelley, seconded by Brent Katz, to approve that approximately 600 cubic yards of sediment be donated to the cancer garden. Motion Carried.

The Nitrogen Reduction Act and The Nature Conservancy nitrogen management programs were reviewed. Thirty-two applications have been submitted so far for the 2026 crop year.

Scott stated that Jason Pohlmann and Ryan Birkett submitted applications to be the Nebraska advisor to the Blue River Compact.

Scott told the Board that Adam Erikson has stayed on part time this winter to help with maintenance as weather allows. Currently, he expects to be around \$14,000 over budget in the operation and maintenance line item at the end of the fiscal year, however, there are unused funds in other areas of the personnel budget which will cover that amount.

Scott asked those wishing to serve on different committees should let he or the Chairman know before the next meeting.

Tyler informed the Board that the monitoring well south of Diller was drilled this week.
