What is the plan for this year?

This year's dates are:

2.30pm – Latest Departure

For the 'fun day' part of the day you please bring a packed lunch or snacks for your young people and have a picnic in the garden. Soft drinks, cakes and cookies will be available.

How much is an award badge?

This year we have managed to get funding which allows all young people to receive a free badge and certificate. There will be no charge.

Do we need to wear a uniform?

That is entirely up to you. Some schools like to have young people in uniform. Others may prefer the day to be more like a reward day and have them in their own clothes. That is entirely your call.

Parking

As many of you know – Lowe House is not ideal for parking, especially for coaches. There is no parking available for coaches to drop a group and then stay in that place. We would recommend that groups get dropped off on Mill St - the street where the St Helens Sea Cadets is (it is one way, so a car / coach has to enter from Duke St and leave on North Rd) and walk to the front of the Church. This street is always quiet and will make it easier for you to get a group off any transport. Parking for cars is available on small car park on Mill St, or a larger car park on Birchley St. Coaches can park on the nearby Asda or Tesco car parks. Below is more detail with maps to direct you or your driver.

Weather

As with any plan for the British summer time – we cannot guarantee good weather. And the ‘fun day’ does depend on good weather. As the fun day comes after the ceremony you may decide to just leave straight away. If that is not possible, or you want to keep the group out for more of the day and enjoy some time as a group, we do have space in the house for you to gather and have a drink and snack. We aim to keep the café, parish hall and the canteen and break out space free in the house. These spaces could easily hold a couple of hundred people sitting and having a snack and chat, but they would not allow for space for games etc.

Can parents attend?

This is an obvious drawback to this plan, and we are sorry that parents will not be able to attend, and it will make life a lot harder for parishes.

However, feedback and experience from previous years suggest that the vast majority of young people that attend the award ceremony come with or through a school connection. But as the ceremony was out of school time it was difficult for them to plan and lead a trip to the ceremony as a school excursion.

Although this system is not ideal for parents and parishes, we believe it will enable more young people to attend through their school links.

If a parent is not working, can they still come along?

We would ask that due to the nature of the event with the Fun Day in the garden we do not want lots of adults walking around who we do not know.

Therefore, as with any school excursion, we do not think it is good practice at this type of event to have parents coming along with their children. It is a shame, and we know for lots of parents they would love to see their child receive an award, but as I am sure you can imagine, the safeguarding implications of not knowing who is here and why would be difficult to manage.

If a parent wishes to pick up their child after the ceremony, we will prefer that they wait outside and the child goes to them rather than simply tries to walk into the church grounds.

Safety and Risk Assessments

Risk Assessments have all been attached below. Due to the nature of the day we (Animate) cannot be responsible for groups that do come for the day. We will have helpers and adult assistance near the activities and picnic area.

However, the group that you bring has to be the responsibility of the school / parish and the staff accompanying them. You may wish to bring a First Aid qualified member of staff and First Aid kit for your group.

On top of this, you must bring your ticket QR code upon arrival whether this is a digital copy or printed. It is a requirement to know who is in the building for the safety of the young people in the case of an emergency.

As well as this each adult will be given a wristband which must be always worn during the day, once again this is for the safety of all attending the award ceremony to make sure that no one is on site who shouldn't be.

Risk Assessments

Please be aware, I have been given these risk assessments from SJ Leisure themselves. After close inspection, all of them seem to repeat the same risks and hazards. I think normally a company might hire 2-3 inflatables at a time but obviously our award ceremony is different and therefore each risk assessment has been added for each activity as there is not an overall joint one available.

It might seem like a lot of information, but each activity seems to carry the same risks than the one before, so please do not feel too alarmed 😊.

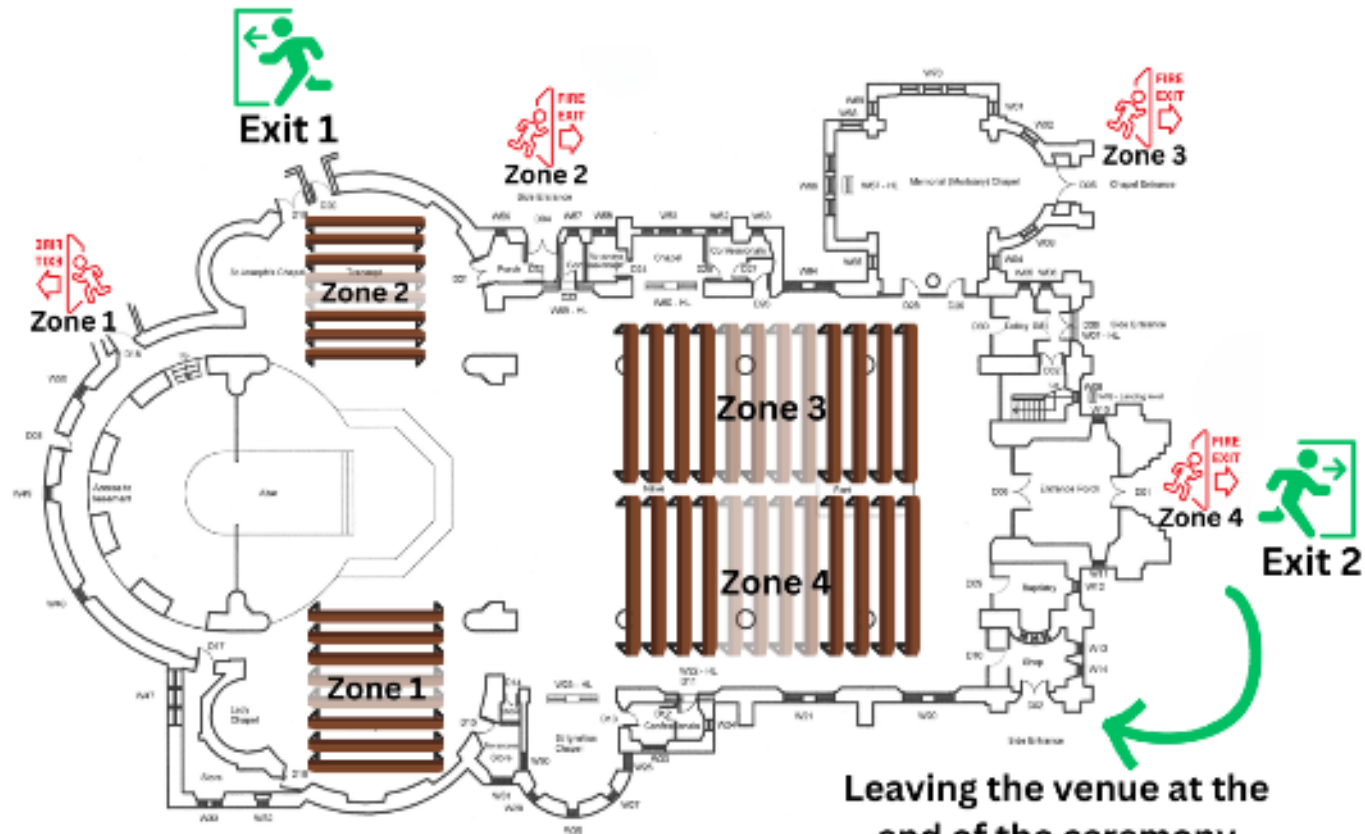

Parking and Arrival Notes

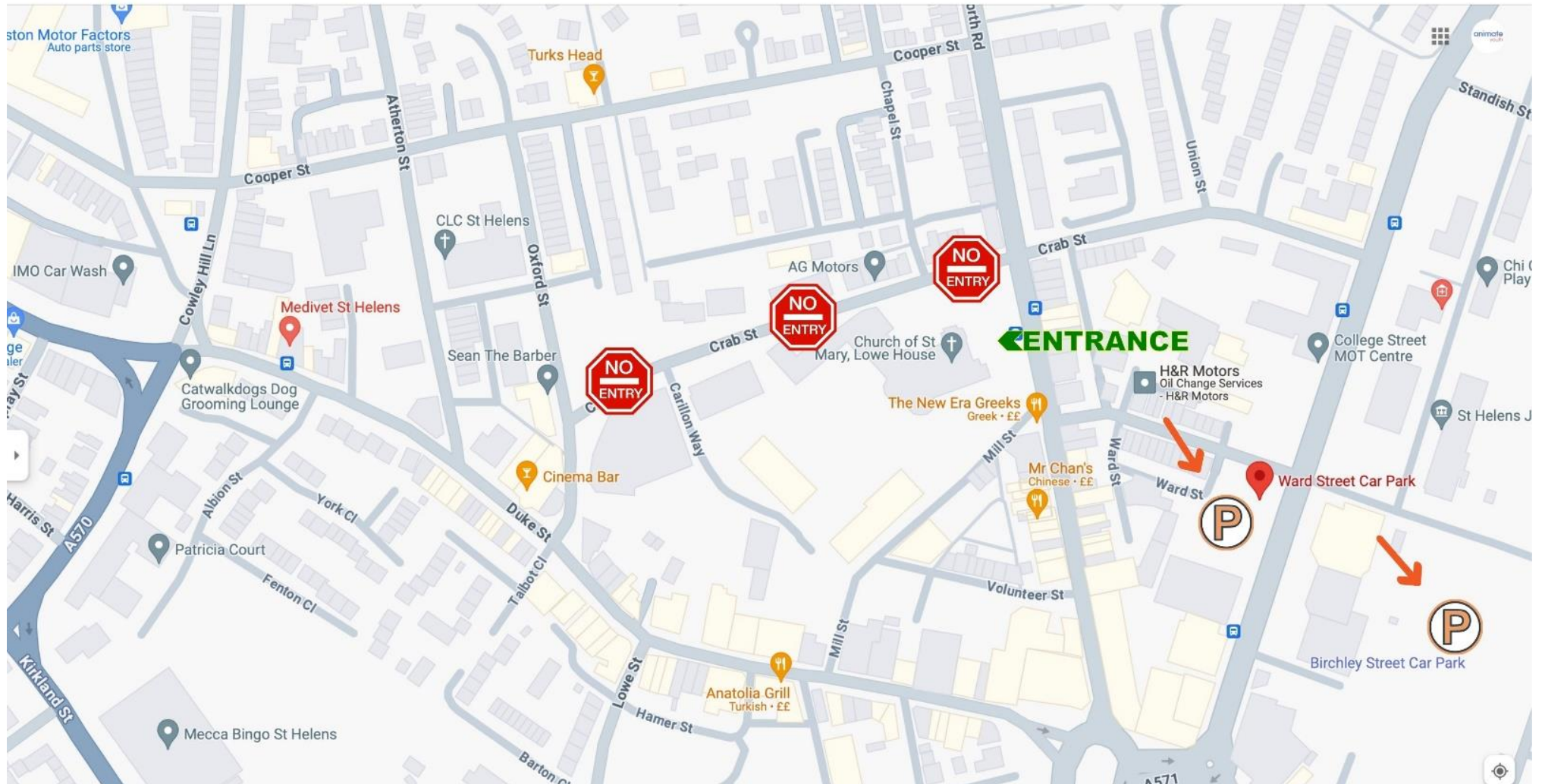

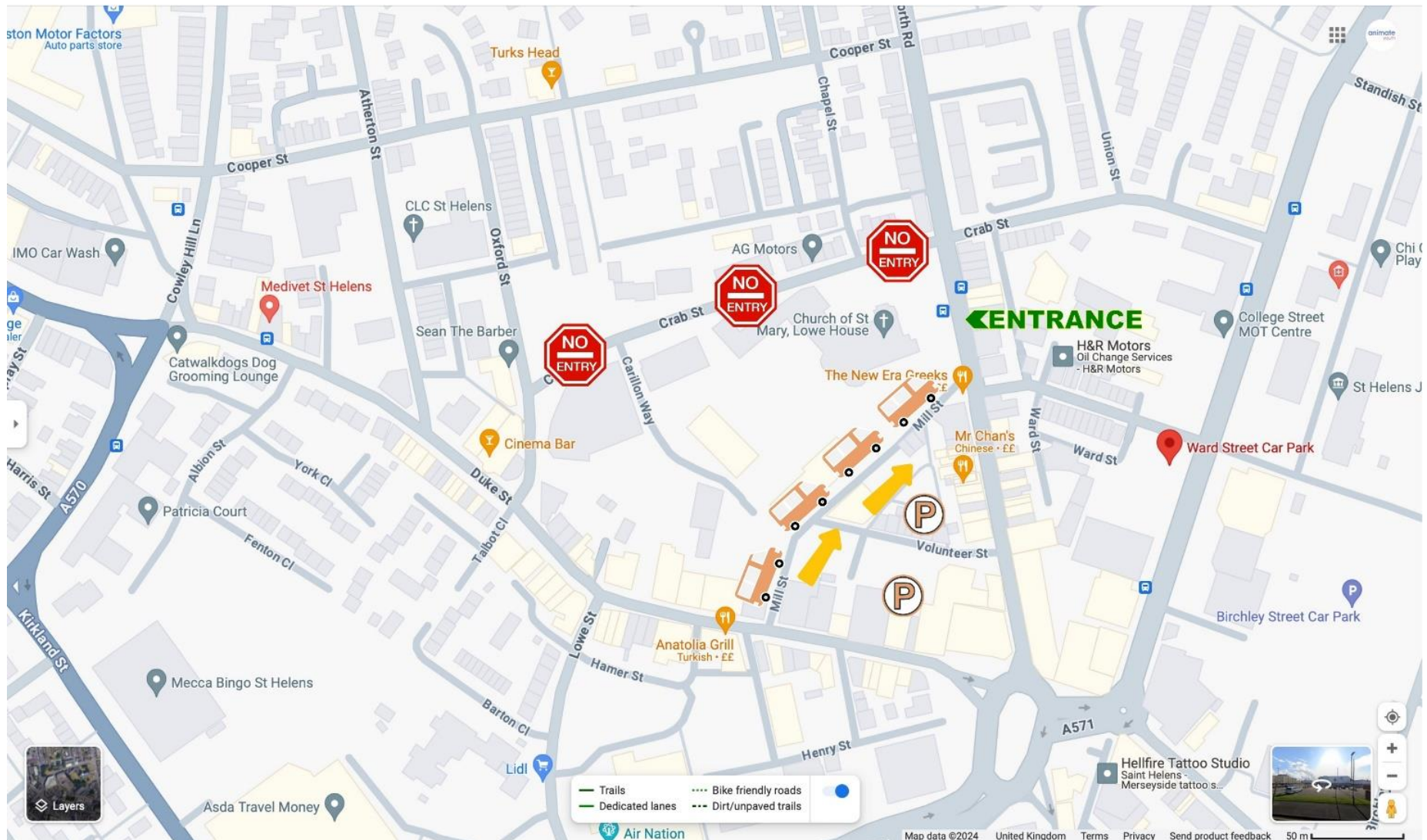

2. Turn onto Cooper St (from North Rd). You might want to use the postcode WA10 2TY to help you find Cooper St. Please do not enter Cooper St from the other end -only use the North Rd entrance.
3. Cooper St is the side road off the address this postcode will take you to.
4. A steward will direct you where to go along Cooper St
5. There will be various drop off spots along this road. You will be directed to an appropriate spot by the stewards.
6. Your group will then walk down the quiet side street to access the Church.
7. In the event that all the drop off points are full you will be asked to continue to the other end of Cooper St and then go left on Cowley Hill Rd (there is an Off Licence / Bread and Wine shop on the right where you need to turn left), then left again to rejoin Duke St (turn left at a cross roads – you will have just gone past a car showroom / garage on the left and there will be a car wash place to the right of you – at the turn there is a Hairdressers). Then follow Duke St until you get to the roundabout with Capitol Squash Club and Hamma Fitness on the left and YMCA in front of you and Molly's Bar on the right. Turn left at the roundabout and that brings you back to North Rd. Continue up North Rd, past the Church, and then go back down Cooper St to start the drop off process again. To go round the block as described here will only take 5 mins.
8. After a drop off a coach must then move away from the area to allow other coaches to use the same drop off areas.
9. We cannot tell coaches where to park. Below are some suggestions that would be easy for a coach to navigate to and have space to park a coach. However, please note that parking in these areas as it at the risk of the driver:
 - Tesco car park (WA9 3AL)
 - Street parking around Victoria Park (E.g. Bishop Rd, WA10 6UX, WA10 6TZ)
 - Street Parking around Merton Bank Road (use WA9 1DZ for destination)
 - Street Parking on Boardmans Lane (use WA9 1QU)
 - Space at the back of Mecca Bingo (WA10 2EG) – Go onto Mecca and follow the drive round the back of the building
