Introduction

These software release notes cover all system modifications for versions v7.90.0 and v7.91.0 of the Finova Broker CRM platform.

The release notes list the bug fixes and known issues provided in this release and are aimed at system operational users.

Testing of the release

New features

V7.90.0

Column totals now added

We've updated the Business Intelligence widgets in Intermediary Manager CRM. Column totals will now be displayed beneath each MI graph.

V7.91.0

Smoother scrolling for user lists

We have fixed an issue where scrolling through long user lists on the dashboard would skip entries. You can now browse and select users smoothly, without missing anyone.

Clearer visuals for product sub-types

You can now assign colours and icons to each product sub-type, making it easier to identify and differentiate them in the recent products widget.

New event actions for Fact Find submissions

You can now set up custom actions in the customer portal, like triggering an email notification when an applicant submits their fact find.
