The shareholders of Sleep Cycle (as defined below).

Notification of the acquisition of control of a listed company – Altor Fund Manager AB

Altor Fund Manager AB (“**Altor**”) is an alternative investment fund manager (AIFM) pursuant to the Swedish Alternative Investment Fund Managers Act (SFS 2013:561) (the “**AIF Act**”). Altor manages the alternative investment funds (AIF) Altor Fund V (No. 1) AB and Altor Fund V (No. 2) AB (together the “**Altor Funds**”). The Altor Funds have, jointly, indirectly acquired shares in Sleep Cycle AB, registration number 556614-7368 (“**Sleep Cycle**”) (the “**Transaction**”) and the Altor Funds jointly control Sleep Cycle. Further details on the structure of the Altor Funds’ holding in Sleep Cycle follows from the group structure chart, attached hereto as Appendix 2.

Altor hereby notifies the shareholders of Sleep Cycle pursuant to Chapter 11, Section 7 of the AIF Act and Chapter 11, Section 3 of the Swedish FSA’s Regulations Regarding Alternative Investment Fund Managers (FFFS 2013:10) (the “**AIF Regulation**”).

Requirements under Chapter 11, Section 7 of the AIF Act

The resulting situation in terms of voting rights

The voting rights of the Altor Funds are set out in Appendix 1.

The indirect ownership percentage and voting percentage of the Altor Funds as well as of each Altor Fund in Sleep Cycle is set out in Appendix 1.

The date on which control was acquired

The Altor Funds acquired control of Sleep Cycle on 10 July 2026.

The identity of the AIFMs which either individually or in agreement with other AIFMs manage the AIFs that have acquired control

The Altor Funds are managed by Altor.

The policy for preventing and managing conflicts of interest, in particular between the AIFM, the AIF and the company, including information about the specific safeguards established to ensure that any agreement between the AIFM and/or the AIF and the company is concluded at arm’s length

Altor will apply the procedures that follow from Altor’s *Conflicts Handbook* in relation to any conflicts that may arise as a consequence of the Transaction.

The policy for external and internal communication relating to the company in particular as regards employees

Any internal or external communication in Sleep Cycle will be dealt with in accordance with the applicable communication policy that Sleep Cycle applies.

Andreas Hamrin, Press Contact at Altor Equity Partners AB, will be responsible for any external communication from Altor in relation to Sleep Cycle.

Internal communication between Altor and Sleep Cycle is made through the Altor representatives in the boards of the group.

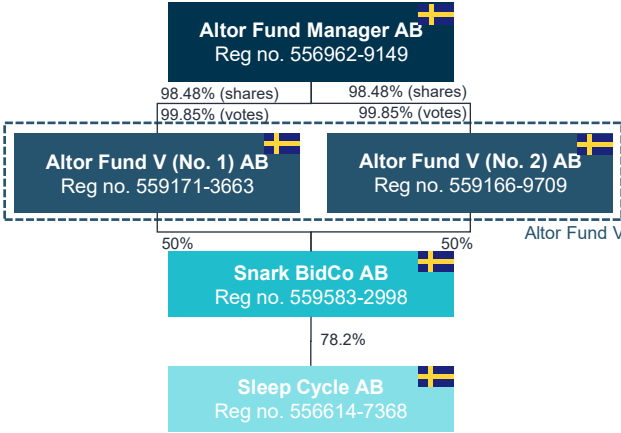
