

Access to Climate Solution Companies in Low- and Middle-Income Countries: Constraints for U.S. Retail Investors

This research examines the extent to which U.S. retail investors can access public climate solution companies headquartered in low- and middle-income (LMI) countries through U.S.-listed exchange-traded funds (ETFs) and mutual funds. As global climate mitigation increasingly depends on innovation and deployment in the Global South, understanding capital access constraints is critical.

Carbon Collective compiled a comprehensive dataset of publicly listed companies across countries in the Global South that derive more than 50% of their revenue from climate solution activities, including renewable energy, clean transportation, energy efficiency, and climate-enabling infrastructure. This process yielded 999 qualifying companies across most Global South countries with public equity markets. Carbon Collective then cross-referenced this universe against more than 30,000 U.S.-listed ETFs and mutual funds to evaluate investability for U.S. retail investors.

The analysis found that only 189 of the 999 identified companies had any exposure within U.S.-traded ETFs or mutual funds, with a combined assets under management (AUM) of approximately \$23 billion. Importantly, more than 99% of this AUM exposure is concentrated in companies headquartered in developed and emerging markets, with frontier and standalone markets almost entirely excluded.

Five key observations emerge from the findings:

- 1. First, it is not currently possible for U.S. retail investors to obtain broad and targeted exposure to LMI climate solution companies. Funds that reach higher exposure levels (20–30%) typically hold only a small number of companies and are either narrowly thematic (e.g., clean energy) or country-specific (e.g., Vietnam).
- 2. Second, most identified climate solution companies are headquartered in frontier markets, which remain largely inaccessible to U.S. investors outside of a limited number of single-country funds.
- 3. Third, 810 companies—representing the majority of the dataset—are entirely excluded from U.S. ETFs and mutual funds, with 16 countries showing zero exposure to LMI climate solution companies.
- 4. Fourth, China, Brazil, and India account for approximately 98% of total AUM exposure, underscoring a high degree of geographic concentration.
- 5. Fifth, while generic emerging market funds may include a relatively large number of LMI climate solution companies, such exposure typically represents only around 1% of total fund assets.

These outcomes reflect structural barriers faced by U.S.-listed funds when allocating to frontier markets, including limited liquidity, market accessibility restrictions, custody and settlement complexity, regulatory and disclosure inconsistencies, benchmark exclusion, and higher perceived political and currency risk. Together, these constraints significantly limit the ability of U.S. retail investors to channel capital toward climate solutions in the regions where mitigation and adaptation needs are greatest.
