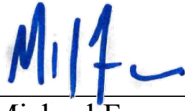

STIPULATION OF VOLUNTARY DISMISSAL

It is hereby stipulated between Plaintiffs Citadel Securities Americas LLC, Citadel Securities Americas Services LLC, Citadel Securities (Europe) Limited, and Citadel Management (Europe) II Limited (collectively, “Plaintiffs”) and Defendants Portofino Technologies AG and Portofino Technologies USA, Inc. that the above-entitled action is dismissed with prejudice pursuant to F.R.C.P. 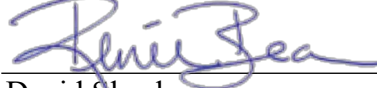
