Robert "Bob" Grier Parke, Jr., HARA Treasurer & Corporate Liaison

March 28, 1945 - September 3, 2025

Bob passed away peacefully at Torrance Memorial Hospital after a long and courageous battle with kidney cancer.

Born to Robert and Peggy Parke in Cleveland Ohio and moved to California as a young boy. Bob graduated from South High School in Torrance, California (1963). He then earned a Bachelor of Business Administration in general management from the University of Houston (1968), and later a Master of Business Administration from the University of Southern California Marshall School of Business (1975). Additionally, he completed the Executive Management Program at the University of California Los Angeles (1988).



Bob served in the U.S. Army from 1968 to 1972, where he distinguished himself as a captain, helicopter pilot, and field artillery officer. His commitment and bravery were recognized through commendations, including the Distinguished Flying Cross, 37 Combat Air Medals, two Army Commendation Medals, and the Bronze Star. These experiences imbued him with values of leadership, discipline, and integrity that he carried throughout his career.

Upon transitioning to civilian life, Bob enjoyed considerable success in the business world. From 1972 to 2000, he worked at Hughes Aircraft Company, ultimately serving as the vice president of human resources.

Bob was also an active member of his community, served on the board of trustees for the Palos Verdes Library District since 2019 and became president in 2023. His legacy of service extended to organizations such as Daedalians, Children's Dental Center, Junior Achievement of Southern California, Hughes Aircraft Retirees Association, the Palos Verdes Golf Club Scholarship Foundation, and the Peninsula Friends of the Library.

Bob is survived by his beloved wife of 56 years, Sharron Parke; his children, Kristi Ikemori (Ian), Greg Parke, and Alex Parke; his grandchildren, Keili and Keira Ikemori and more.

Donna McGovern

March 26, 1945 - June 25, 2025

Donna hired into Hughes Aircraft Company from 1963-1966 for a brief stint in Space and Communications, as an Administrative Assistant. She was again hired in 1977 and immediately transferred to the newly formed EDSG division and moved into the E1/E4 complex as soon as it was completed. She worked in Production Control and eventually was promoted to Department Head, supporting several programs with Configuration Control, Storerooms, and Shop Floor Control. She participated in introducing robotics for parts and supply movement to the Production Floor as well as circuit card automated population. She retired from EDSG in 2000. In 2005, she was rehired into the Radar Division, this time. She lead a team of Production Control Specialists supporting all Radar programs with warranty, repair and retrofit functions. She retired for the final time in 2014, with a total of 35 years with Hughes/Raytheon. Donna has been a member of HARA since



2000. She headed up the travel activities for a short period and accepted the Secretary position in 2016, along with the Sunshine Chair and liaison for the hugheshara.org website.
