## **How to Play?**



What is the age of consent in Pakistan?

The age of consent in Pakistan is 18 years for girls and boys. The age of consent in Pakistan is a federal issue and hence is 18 years for girls and boys. The age of consent in Pakistan is a provincial issue and hence differs for girls and boys in each province.
