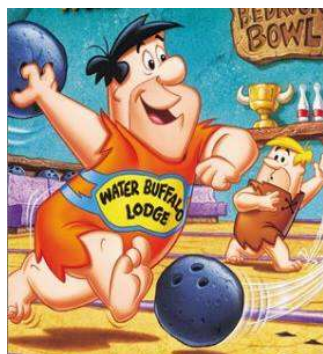

1. This tournament is open to all current Male USBC members, in good standing. Members not sanctioned with Carson Country USBC may enter by paying the appropriate (national, state and/or local) membership dues.

2. **Tournament shall consist of a three-man team event, with an optional virtual singles event.**
 Three consecutive games shall be bowled, and total pins shall decide the winner.

3. There will be two team divisions and two singles divisions:

TEAM EVENT

Div. 1 – 600 & up
 Div. 2 – 599 & under

SINGLES EVENT

Div. 1 – 200 & up
 Div. 2 – 199 & below

4. The entry fee for this tournament will be \$45.00 (lineage of \$12.00, expenses of \$6.00 and prize fund of \$27.00) per person for Team event (\$135.00 per team). The tournament shall consist of a Team Trio's, 3-game event with an Optional Virtual Singles Handicap and/or Scratch event for an additional \$10.00 per event.

5. Entry fees may be paid via cash, check, money order or venmo. Make checks payable to CCUSBC. Entrant is responsible for returned checks; a \$40.00 collection fee will be charged. If a check is returned, the entrant will be required to pay the entry fee and bank fees via cash prior to squad time or entry will be voided.

WALK-INS allowed with a \$5.00 Fee(will be added to prize fund) up to 30 min prior to start. If insufficient entries by Wednesday prior, tournament or some squads may be cancelled.

6. Entrants must use their highest USBC sanctioned league average, regardless of whether bowled as a regular member or a substitute. **Note that USBC Rule 319a (ten pin rule) will apply.** *When the previous season's average is used, and at the time of bowling an entrant has an average for 21 games or more, that is 10 pins or more than the previous season's average, the current average MUST be used. The player is responsible to notify the tournament director of this change prior to participation in any event. Failure to do so will result in forfeiture in any series in which he bowls (Rule 319a)* **Averages will be accepted in the following order:**

- a. Highest winter 2024-2025 book average (21 games or more).
- b. Highest summer 2025 book average. (21 games or more).
- c. Highest 2023-2024 book average. (21 games or more).
- d. Highest current league average of at least 21 games (verified by League sheet/attached to entry).
- e. Entrants with no average will enter at 240 scratch.

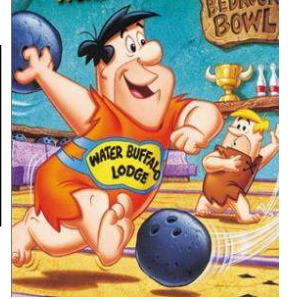
Averages will be adjusted according to USBC rules for all Tough Shot Leagues, PBA Leagues and Sport Shot Leagues or ANY league that changes patterns for their league throughout the season.

7. Handicap will be determined on a game basis, based on **90% of 240** and applied to each bowler.
8. Entrants are required to check in no less than 30 minutes prior to squad time for lane assignments and presentation of USBC card. Any participant arriving after the game has started will be allowed to bowl and the score will count beginning in the frame then being bowled. No score will be given for the frames missed.
9. The prize money will be returned 100% on a ratio of 1 in 5 teams, or a major portion thereof. Prize checks will be distributed within 30 days after the tournament closes (except when USBC has authorized delay in payment pending the settlement of any claim or protest that affects position standings). Optional Virtual Singles will be returned 100% on a ratio of 1 in 10 bowlers, or a major portion thereof.
10. In the event of ties for cash prizes, money for the places tied will be divided accordingly.
11. The main tournament shall consist of bowling a Team's 3-game event with an Optional Virtual Singles Handicap 3-game event for an additional \$10.00 and a Virtual Singles Scratch 3-game event for an additional \$10.00. Scores bowled in Team will be used virtually for the singles events. You do not bowl singles separately. Three consecutive games shall be bowled on a single pair of lanes and total pins shall decide the winner.
12. A maximum of two Team entries per bowler will be allowed. You can only cash once with the same team. Virtual Singles is limited to one entry per bowler.
13. Substitutes will be permitted.
14. All recaps should be signed by the Team Captain. Each bowler is responsible to verify that her scores have been written correctly as all recaps are official records of scores bowled. If recaps are not signed, scores will be accepted as read.
15. Errors in scoring must be reported prior to the start of the next squad.
16. Disputes involving pin fall, fouls, etc., must be referred to the tournament officials in the frame in question. Bowlers will not make corrections to the scoring units or recap sheets without a Tournament Official's approval.
17. Any protest affecting eligibility or playing rules must be submitted in writing to the Tournament Manager before the tournament prize payments are made. Recaps are official records of scores bowled.
18. Only bowlers and officials will be allowed in the playing area. No food or beverages will be allowed in the playing area. Only Tournament Officials will be allowed to program, correct, and record scores.
19. Bowlers using loud or abusive language or conduct unbecoming of a bowler shall have one warning. If misconduct continues, bowler will be removed from the lanes. The bowler will forfeit any awards and prize money for that event.
20. Reasonable attire is required (no tank tops or sleeveless shirts are allowed), and determination is at the discretion of the Tournament Management.
21. The tournament officials are authorized to remove a player for an infraction of USBC and/or CCUSBC rules and regulations that apply to this tournament.
22. Entries will be scheduled in the order received. The Tournament Manager, except for an emergency, will not change the schedule. The Tournament Manager will assign lanes for each event. Each event will be bowled on a single pair of lanes. Tournament Management will do its best to accommodate pairings requests if noted on entry form.
23. Should a squad have 4 teams or less, the Tournament Manager reserves the right to not hold that squad. Bowlers will be advised and asked to pick another squad, if available.
24. The oil pattern will be the house shot that has been used for a minimum of 2 weeks prior to the start of the tournament.
25. All applicable USBC Rules not mentioned will apply. Tournament Management shall decide any questions not covered by the rules. **The decision of Tournament Management will be final unless appealed in accordance with USBC Rule 329.**
