Terms and Conditions

1. Promoter

The promoter is RDCCO Pty Ltd trading as Permaconn (ABN 90 625 818 395) of 1 Epping Road, North Ryde NSW 2113 ("Permaconn").

2. Promotion Period

The promotion opens at 12.01am on 6 July 2026 and closes at 11:59pm AEST/AEDT on 31 July 2026.

3. Eligibility

Entry is open to Australian residents aged 18 years or over who complete and submit the Permaconn customer survey during the Promotion Period.

Employees of Permaconn and their immediate family members are not eligible to enter.

4. How to Enter

To enter, eligible participants must complete and submit the Permaconn customer survey during the Promotion Period.

Entry is free. No purchase is required.

Only one entry per person is permitted. Incomplete, duplicate or automated entries may be excluded.

5. Prize

There are five (5) prizes available. Each prize is one (1) prepaid Visa gift card valued at AUD \$250.

The total prize pool is AUD \$1,250.
