**Summary:** A Speech Pathologist, or Speech Therapist, is responsible for helping people communicate and swallow appropriately. Their duties include assessing patients, diagnosing disorders than can impact swallowing and speaking and providing treatment for their patients.

Speech perform duties like assessing, diagnosing, treating and helping to prevent swallowing and communication disorders in adults and children. Swallowing, speech and language disorders result from a variety of causes including autism, a cleft palate, Parkinson's disease, developmental delay, hearing loss, brain injury and stroke.

# **Essential Duties and Responsibilities** include the following:

Speech Pathologists often work with individuals who experience voice disorders such as harsh voice or inappropriate pitch or who are unable to understand language. They are responsible for completing administrative tasks including documenting billing information and keeping accurate records of initial evaluations, diagnoses, treatment progress and any treatment plan notes. In addition, they are responsible for:

- Evaluating levels of swallowing, speech and language difficulty
- Identifying treatment options
- Creating and carrying out individualized treatment plans addressing specific functional needs

- Teaching patients how to make sounds while improving their voices and maintaining fluency
- Helping individuals improve sentence structure and vocabulary used in written and oral language
- Working with adults and children in developing and strengthening muscles used to swallow
- Counseling individuals and families on ways to cope with swallowing and communication disorders
- Speech Pathologists focus on the following areas:
  - Child language disorders: Helping children who have trouble forming words and speaking appropriately for their age.
  - o Fluency disorders: Specialize in fluency disorders help those who suffer from stuttering or similar speech challenges.
  - Swallowing disorders: Specializes in swallowing disorders helps those who have trouble swallowing.

# KNOWLEDGE, SKILLS, AND ABILITIES:

- 1. Attention to detail regarding a patient's problems to analyze what they need to ease their concerns with speech issues
- 2. Work with individuals who experience voice disorders such as harsh voice or inappropriate pitch or who are unable to understand language.
- 3. Responsible for completing administrative tasks including documenting billing information and keeping accurate records of initial evaluations, diagnoses, treatment progress and any treatment plan notes. In addition, they are responsible for:

  - d. Helping individuals improve sentence structure and vocabulary used in written and oral language

  - g. Interpersonal skills to build positive relationships with patients and motivate them
  - h. Communication skills to interact clearly with doctors and family members as well as patients
  - i. Ability to maintain a high level of confidentiality
  - j. Highly dependable, excellent attendance
  - k. Training and licensed/certification in speech therapy
  - l. Excellent attention to detail, particularly for interpreting patient treatment plans

- m. Strong communication skills and the ability to explain technical information clearly to patients
- n. Familiarity with speech therapy related products
- o. The ability to work effectively as part of a team
- p. Excellent verbal and written communication skills
- q. Able to interview patients/clients and document accurately, interact with the public and prospective patients/clients, speak effectively, and be readily available for crisis
- r. Strong verbal and written communication skills
- s. Complete and pass HIPAA training
- t. Ability to organize and prioritize tasks.

# **QUALIFICATIONS AND EXPERIENCE:**

Speech Pathologists need a minimum of a master's degree supervised clinical experience and passing exams. While master's degree programs don't require specific undergraduate degrees for admission, certain coursework is often required to be completed prior to entering a program.

The Council on Academic Accreditation (CAA) which is part of the American Speech-Language-Hearing Association is responsible for accrediting educational programs in speech-language pathology. Certification and state licensure require candidates to graduate from an accredited program.

Speech Pathologists can also earn the Certificate of Clinical Competence in Speech-Language Pathology (CCC-SLP) administered by the American Speech-Language-Hearing Association. Certification usually satisfies many state licensure requirements and is required by some employers.

In order to obtain CCC-SLP certification, applying candidates must have a degree from an accredited program, successfully pass an exam and complete a fellowship while being supervised by a certified Speech Pathologist. An additional 30 hours of continuing education is required every three years in order for Speech Pathologists to maintain their CCC-SLP credentials.
