Pursuant to the provisions of Act No. 45 of April 18, 1935, as amended, the State Insurance Fund Corporation (CFSE, for its Spanish acronym) has a dual responsibility:

- To provide broad insurance coverage that offers protection to insured employers against any legal action that could be brought against them by injured workers in connection with a work-related accident or an occupational disease.
- To provide injured workers with medical and rehabilitation services, as well as economic compensation for occupational accidents or diseases, in order to promote their prompt return to work.

To establish coverage and determine the premium applicable to each employer, the CFSE manages a risk classification system based on the various economic activities (trades and industries) developed in Puerto Rico. The number of classifications may vary on a yearly basis due to the changes in economic activities, particularly due to technological advances and local industry changes. Each classification is assigned an insurance rate based on the loss experience of employers with policies in force.

To establish an employer's coverage, the CFSE assigns each employer one or more classifications, according to the type of operations they conduct. If an employer changes the nature of their operations or suffers significant variations, it may be necessary to change one or more of their assigned classifications.

The policy premium is calculated by dividing the estimated annual payroll for each risk classification by one hundred (100) and then multiplying it by the corresponding classification premium.

The CFSE publishes the Manual of Classifications for Trades, Industries and Insurance Rates on an annual basis, as

technical support. The Manual includes current classifications by business activity and the applicable premium rates, and is governed by the following regulations:

- Regulation to Govern the Workers' Compensation Insurance;
- Regulation to Determine Labor Percentages for Work Subject to Temporary Policies and Validity Certification of Single Permanent Policies of Contractor Employers;
- Regulation for Granting Premium Payment Exemptions to Employers of Technical Personnel in Puerto Rico;
- Regulation to Determine Workers' Compensation Insurance Coverage for Employers or Owners or Individual Business or Industry;
- Regulation for Employers Performing Manual Labor in Workshops, Farms or Small Businesses;
- Employer Experience Rating Plan Regulations.

For fiscal year 2025–2026, the Manual of Classifications for Trades, Industries and Insurance Rates will include one hundred ninety-one (191) classifications that comprise the economic activities developed in Puerto Rico. The Manual incorporates the recommendations and comments gathered during the Public Hearings for Employers, which were held in March and April 2025 in Aguadilla, Caguas, Carolina, and Ponce.

It should be noted that, for the first time since 2018, a thorough review of the classification system was performed. As a result, one hundred twenty-five (125) classifications show a rate reduction as compared to the previous year. This

represents a significant relief and generates a positive impact for employers.

The Manual Review Committee is composed of professionals from different areas within the CFSE with extensive experience in regulatory compliance and policy administration. Its members include Mr. Luis Ricardo Eliza Márquez, Acting Assistant Administrator for the Insurance Area and Committee Chair; Mr. Germán Acevedo Domenech, Director, Actuarial Affairs Office; Ms. María T. MINIMUM PREMIUM

The MINIMUM PREMIUM shall be computed by multiplying the highest premium rate included in the policy by three (3). The Minimum Premium for regular or permanent policies shall never be less than NINETY-NINE DOLLARS (\$99.00) per policy year, provided that the minimum premium will be divided from the date of formalization until the close of the fiscal year. The Minimum Premium for contingent or temporary policies shall never be less than NINETY-NINE DOLLARS (\$99.00) for each period of twelve (12) calendar months, from the start date until the end date of the policy.

The final premium, in the event of liquidation and/or cancellation, shall be subject to the Minimum Premium computed, as provided above. In compliance with the provisions of Articles 23 and 24 of Law 45, known as the "Workplace Accident Compensation System Act," passed on April 18, 1935, as subsequently amended, the classifications are established for the foregoing trades and industries and the corresponding premium rates that shall govern for the financial year beginning on July 1, 2025 and ending on June 30, 2026. These rates shall be applied to the total sum of wages, salaries, and other remuneration paid by the employer to the workers employed by said employer.

PURSUANT TO THE WORKERS' COMPENSATION SYSTEM ACT, AS AMENDED, AND ALL CURRENT REGULATIONS, THE PAYROLL OF ALL EMPLOYEES AND EXECUTIVE OFFICERS OF CORPORATIONS SHALL BE SUBJECT TO TAXATION BASED ON THE TOTAL WAGES, SALARIES, AND OTHER REMUNERATIONS PAID TO THEM.
