DIRECTIONS FOR USE

READ ENTIRE LABEL BEFORE USING SHAKE WELL BEFORE USING NOT FOR AQUATIC USE IN CALIFORNIA OF WASHINGTON STATE

WindSurf Pro was developed for use with all pesticides, fertilizers and other plant protectants. If the applicator does not have experience using this product, a phytotoxicity and jar test should be performed to confirm plant safety and tank mix compatibility with a specific spray mix. WindSurf Pro should generally be added last in the spray mix, unless buffering the spray solution is desired and then WindSurf Pro should be added first in the spray mix. Care must be taken in treating plant during periods when plants are subjected to drought stress, high temperature and high humidity. The pesticide manufacturer's label for specific usages and restrictions have precedence over DIRECTIONS FOR USE referred to on this label and so rates can be adjusted up or down as necessary.

<u>Turf (Including but not limited to golf courses, commercial, residential, sports turf, sod farms, parks)</u>: $\frac{1}{2}$ to 4 pints per 100 gallons of spray solution (0.0625 – 0.5% v/v).

Ornamentals (including but not limited to greenhouses, nursery, landscapes, transplanted crops): Special caution should be used when applying over ornamentals. Plant safety may be a concern and user should test appropriately to confirm acceptable safety. $\frac{1}{2}$ to 4 pints per 100 gallons of spray solution (0.0625 – 0.5% v/v).

Industrial (including but not limited to vegetation management, roadsides, railroads, aquatics, range and pasture): $\frac{1}{2}$ to 4 pints per 100 gallons of spray solution (0.0625 – 0.5% v/v).

Aquatics (where registered): ½ to 4 pints per 100 gallons of spray solution (0.0625 – 0.5% v/v).

Pest Control: ½ to 4 pints per 100 gallons of spray solution (0.0625 – 0.5% v/v).

Other Crops (including but not limited to herbs, vegetables, fruit, nuts, hops): $\frac{1}{2}$ to 4 pints per 100 gallons of spray solution (0.0625 – 0.5% v/v).

STORAGE AND DISPOSAL
