

**CITY OF STARBASE, TEXAS  
ORDINANCE NO. 2025-08-20-D04-OR**

**AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF STARBASE, TEXAS, *NUNC PRO TUNC*, CORRECTING A SCRIVENER'S ERROR IN THE MUNICIPAL BOUNDARIES SURVEY ADOPTED BY ORDINANCE NO. 2025-05-30-F01-OR; PROVIDING FOR A SAVINGS CLAUSE AND AN EFFECTIVE DATE.**

**WHEREAS**, on May 30, 2025, in accordance with Texas Local Government Code Section 41.002 the City Commission approved Ordinance No. 2025-05-30-F01-OR adopting the municipal boundaries survey; and

**WHEREAS**, the municipal boundaries survey and incorporation petition contained a scrivener's error that included a small portion of an approximately 939.469 acres tract, Cameron County CAD property ID 171645, hereinafter the "Property"; and

**WHEREAS**, it was not the intent of the incorporation petitioner or the City Commission to include a portion of the Property within city limits while the remainder of the Property remained outside city limits; and

**WHEREAS**, City staff requests that the scrivener's error be revised to correctly reflect the municipal boundaries in the revised municipal boundaries survey attached to this Ordinance as Exhibit A; and

**WHEREAS**, the City Commission has the inherent power to correct such mistakes to accurately reflect its official actions; and

**WHEREAS**, the City Commission finds that said nunc pro tunc correction is in the best interest of the citizens of the City of Starbase and should be adopted as stated herein.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF STARBASE, TEXAS THAT:**

**Section 1.** All of the above premises are found to be true and correct and are incorporated into the body of this Ordinance as if copied in their entirety.

**Section 2.** Ordinance No. 2025-05-30-F01-OR is hereby amended with the correct municipal boundaries survey attached as Exhibit A, to reflect all property within the City of Starbase city limits upon incorporation.

**Section 3.** All other provisions of Ordinance No. 2025-05-30-F01-OR not specifically amended or deleted herein shall continue in full force and effect from the date of original passage on May 30, 2025.

**Section 4. Severability.** It is hereby declared to be the intention of the City Commission that the sections, paragraphs, sentences, clauses and phrases of this Ordinance

are severable, and if any phrase, clause, sentence, paragraph or section of this Ordinance shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this Ordinance, since the same would have been enacted by the City Commission without the incorporation in this Ordinance of any such unconstitutional phrase, clause, sentence, paragraph or section.


**Section 5. Repealer.** This Ordinance shall be cumulative of all provisions of all ordinances of the City of Starbase, as amended, and shall not repeal any of the provisions of such ordinances, except in those instances where provisions of such ordinances are in direct conflict with the provisions of this Ordinance.

**Section 6. Engrossment/Enrollment.** The City Clerk is hereby directed to enroll and engross this Ordinance by reflecting the passage of this Ordinance in the minutes of the City Commission and by filing this Ordinance in the Ordinance Records of the City.


**Section 7. Effective Date.** This Ordinance shall take effect immediately upon its passage and approval.


