

TERMS AND CONDITIONS

Welcome to the Randridge Mall – Gold Rush Spend & Win Competition ("the Competition"), conducted by Randridge Mall ("the Promoter"). These rules constitute the official terms and conditions governing the Competition.

1. Competition Period

- 1.1 The Competition is valid from 5 November 2025 to 30 November 2025, during Randridge Mall's standard trading hours.
- 1.2 No entries will be accepted before or after this period.

2. Eligibility

- 2.1 The Competition is open to South African residents aged 18 years and older.
- 2.2 Participants under the age of 18 must obtain consent from a parent or legal guardian to participate.
- 2.3 No person who is a manager, director, member, partner, employee, agent, consultant or tenant of the Promoter, the marketing service provider or any person who directly or indirectly controls or is controlled by the Promotor or their immediate family members, spouses, life partners or business partners is eligible to participate in or enter this Promotion.

3. How to Enter

- 3.1 To qualify, shoppers must spend a minimum of R150 or more at any participating Randridge Mall store during the competition period. One (1) sticker will be issued per qualifying transaction.
- 3.2 Multiple till slips may be combined to reach the minimum spend of R150, provided all purchases were made during the competition period.
- 3.3 Shoppers must collect five (5) golden stickers from participating stores to complete their entry form.
- 3.4 Completed entry forms must have the till slip(s) securely stapled to the form entries without attached till slips will be deemed invalid.
- 3.5 Completed entries must be placed in the official entry boxes located at Entrances 1 and 3.
- 3.6 Each till slip may only be used once and must reflect purchases made within the valid competition dates.
- 3.7 Multiple entries are permitted, provided each entry is accompanied by new qualifying till slips and a completed entry form.

4. Prize Details

4.1 One (1) lucky shopper will win R10 000 in shopping vouchers, which includes R5 000 in Pick n Pay vouchers.



- 4.2 The remaining R5 000 in shopping vouchers may be allocated by the winner to a maximum of five (5) stores within Randridge Mall, with a minimum of R1 000 per selected store.
- 4.3 The selected stores must be tenants of Randridge Mall and approved by Centre Management prior to voucher issuance.
- 4.4 The winner must allow the Promoter up to ten (10) working days from confirmation of store selection to process and prepare the prize vouchers.
- 4.5 The prize is not transferable, not exchangeable for cash, and cannot be substituted for any other goods or services.
- 4.6 The winner will be selected via a random draw conducted by the Promoter or its appointed representatives after the closing date.
- 4.7 The winner will be contacted telephonically and/or via email. If the winner cannot be reached within five (5) working days, a new winner may be selected.

5. General Rules

- 5.1 By entering, participants agree to abide by these Terms and Conditions.
- 5.2 The Promoter reserves the right to verify entries, till slips, and participant eligibility.
- 5.3 Any falsified, incomplete, or tampered entries will be disqualified at the Promoter's discretion.
- 5.4 The Promoter's decision regarding any aspect of the Competition is final and binding, and no correspondence will be entered into.

6. Limitation of Liability

- 6.1 The Promoter is not responsible for any loss, theft, or damage to entries or prizes once collected or redeemed.
- 6.2 The Promoter will not be liable for any technical errors, delays, or issues that may occur during the promotion or prize redemption process.

7. Privacy

7.1 By entering, participants consent to the Promoter collecting and using their personal information solely for the purposes of administering the Competition, in accordance with the Protection of Personal Information Act (POPIA).

8. Amendments

8.1 The Promoter reserves the right to amend, suspend, or cancel the Competition or alter these Terms and Conditions at any time without prior notice, should unforeseen circumstances arise.

9. Governing Law

9.1 This Competition is governed by the laws of the Republic of South Africa.
