Board Retreat Follow up - Joli Mosier

- Reviewed 2024 Goals and priorities
- Received a proposal from Al Kidd and Jennifer Stoll of Cimarron Global Solutions on how to continue their consulting services with SSC
- Ensure SSC is being consistent with narrative, key messaging and branding
- Working with Kelly Saling on economic impact for World Cup; Want to be supportive and amplify that message and also incorporate metrics from other cities
- Contact pro teams & colleges to see if they want to work together and produce community events and SSC would be the convener
- Run a similar program to Kansas City's Sports Commission & Foundation
- Bring in companies to help with the LLC on these projects
- Preparing and working on (3) different parades and routes so they are pre-planned

President's Report & Discussions - Beth Knox

- Region Ready Recap
 - o Had great attendance and proud of the panel and content
 - Thinking of how future Region Ready's will look in 2025 & 2026; What is the goal and attendance?
 - Discussed having our Annual meeting and then attending Region Ready or vice versa to consolidate the number of meetings.
- Sports Star Television Broadcast Discussion
 - Viewership = 60,000 household views
 - o 4.2 Rating
 - (4) airings (2 on King TV & 2 on Kong TV)
 - Previous year on Fox had 12k+ views; First year with King had 40K views
 - Dramatically increased our viewership with King & Kong TV
 - Currently don't pay a broadcast fee and haven't sold any ads
 - Selling the broadcast would have the most revenue; King did sell a portion of it
 - Review our social media #'s, including King TV's around the event and see how we can improve these views and event awareness
- Board and Commissioner Meetings and Engagement Discussion (Pamela, VP Partnership)
 - Working with all the teams to get more social engagements for the Commissioner and Board members
 - o SSC Intern has sold \$9k for the golf tournament
 - Would like to continue to receive individual invitations to various sporting events for the members



- Professional Auto Racing / SSC Opportunity
 - Pacific Raceways extended an invitation to Nascar to host an event there, and Pacific Raceways would then renovate the track. Nascar passed on the opportunity
 - The International Motor Sports Association (IMSA) is interested in the Pacific Raceways track and are discussing bringing a race to the track after 2026's World Cup.
 - o IMSA is interested in the innovation of racing and feel this would be a great location for a future race, especially with the tech companies located in our area.
 - Pacific Raceway approached Beth to see if SSC would be interested in being the sales arm to the raceway track, naming rights, concessions; Revenue would be generated for SSC and it could be a long term partnership
 - Consider additional revenue streams in which we can participate
- Awarded & Bid Updates (Alex, Director of Sporting Event Development)
 - The first boat arrived for the Clipper Around the World race and there will be 3 days of activations next week
 - Reviewed the bid for the 2030 Gay Games. It required a bid structure of \$60,000 and many pages of production. Passed on it this time but may pursue it in the future.
 - o Also passed on the LIV Golf tour which is too much of a risk and doesn't align with our mission

SSC Foundation - April Kyrkos

- Working on aligning the foundation and SSC together
- Focusing on youth sports
- Trying to create a playbook for more fundraising
- Excited to create a softball and baseball legacy program
- Work with the Mariner's nonprofit charitable organization, Mariners Care so we can give back to the community
- Assemble a committee on how to structure it and expand youth sports in the area

- The December Board & Commissioner meeting will be on the same day, Tuesday, December 17. The Board meeting will take place first and then go into the Commissioner meeting.
- Pamela is going to the NFL Draft in Detroit Michigan from April 25-27.
- Continuing to work on the SSC rebrand utilizing urban elements and the outdoors, Space Needle, etc.
