Hate Crime Law still warranted in SC

Thank you to local governments which have adopted Hate Crime Ordinances all others to include school districts are encouraged to adopt Hate Crime Ordinances or Policies.

Hate crime ordinances, at both state and local levels, typically aim to provide enhanced penalties for crimes motivated by bias against a victim's race, religion, ethnicity, national origin, sexual orientation, gender, disability, or other protected characteristics. These laws acknowledge that crimes driven by prejudice inflict a deeper societal harm beyond the immediate offense, often terrorizing entire communities and undermining social cohesion. By recognizing and punishing such bias, these ordinances seek to deter acts of hate, promote equality, and send a clear message that discrimination-motivated violence will not be tolerated within a jurisdiction. They often work by allowing judges to impose longer sentences or higher fines when a perpetrator's intent to target a victim based on these characteristics is proven.

Despite the prevalence of hate crime legislation in many states, South Carolina remains one of the few without a statewide hate crime law. While federal hate crime statutes can be applied in certain cases, their scope is limited, and they do not cover all bias-motivated crimes that might occur within the state. This absence means that individuals who commit crimes motivated by hate in South Carolina may not face the same enhanced penalties as they would in jurisdictions with such laws. Advocates for a state-level hate crime law argue that its implementation would provide stronger protections for vulnerable communities, deter bias-motivated violence more effectively, and align South Carolina with the majority of other states that have adopted similar legislation. H 3578 Cursive Writing Bill - A BILL TO AMEND THE SOUTH CAROLINA CODE OF LAWS BY AMENDING SECTION 59-29-15, RELATING TO THE REQUIREMENT THAT CURSIVE WRITING BE TAUGHT IN PUBLIC ELEMENTARY SCHOOLS, SO AS TO SPECIFY THAT THE CURSIVE WRITING INSTRUCTION MUST BEGIN IN SECOND GRADE AND CONTINUE IN EACH GRADE THROUGH FIFTH GRADE. This Bill unanimously passed the House. and it was sent to the Senate. The Senate referred it to their Education Committee.
