## **SCLBC ANNUAL RETREAT December 5-7, 2025**

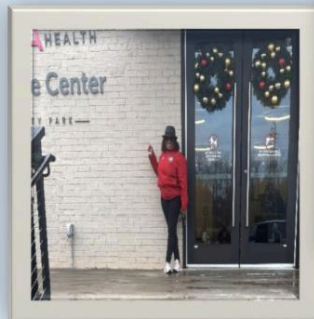
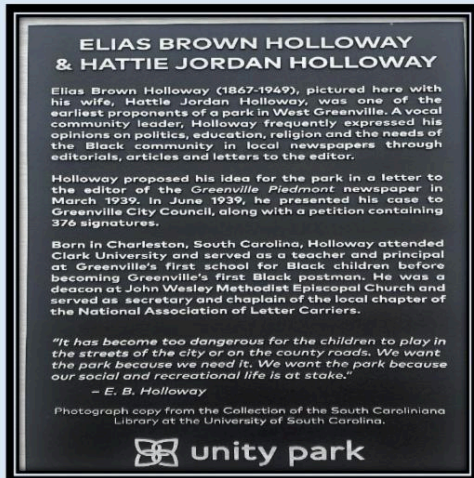

## SCLBC PRE-FILED AND 2025 LEGISLATION AND PRIORITIES FOR THE 2026 LEGISLATIVE YEAR

As we approach the second year of the 126<sup>th</sup> South Carolina General Assembly, the mission to protect the rights, history, and economic future of Black South Carolinians remains our highest priority. The upcoming 2026 legislative session represents a critical juncture for both long-delayed justice and the defense of educational integrity.

### A. I. Closing the Gap on Justice: The Clementa C. Pinckney Hate Crimes Act

South Carolina remains one of only two states in the nation without a statewide hate crime law. We call for the immediate passage of the Senator Clementa C. Pinckney Hate Crimes Act (S. 247/H. 3039).



**The Mandate:** This legislation is not merely a legal enhancement; it is a moral necessity. By providing penalty enhancements for crimes motivated by race, religion, or identity, South Carolina can finally declare that hate has no sanctuary within our borders.

**Status:** Despite repeated passage in the House in previous sessions, this bill awaits Senate action. We demand the Senate leadership prioritize the safety of our communities by bringing this bill to a vote in 2026.

## **B. II. Educational Empowerment: Cursive Writing and Literacy**

The SCLBC continues to support **H. 3578**, which aims to strengthen the state's cursive writing requirements in public elementary schools.

**The Impact:** Literacy is the bedrock of civic participation. By ensuring instruction begins in second grade and continues through fifth grade, we empower students with the skills to read historical documents, sign legal papers, and master fine motor skills essential for early development.

**Status:** Having passed the House with overwhelming support, we urge the Senate Education Committee to move this bill forward to ensure no child is left without these fundamental tools of communication.

## **C. III. Addressing Unfinished Business: Defending Equity and Opportunity**

The **2025** legislative year left several critical issues unresolved and additional legislation has been filed for the **2026** Legislative year. We remain steadfast in our opposition to measures that seek to erase Black History and diminish economic opportunities:

### **Conclusion: A Call to Civic Action**

Our work in the State House is only as strong as the voices of the people we serve. We urge our churches, community leaders, and constituents to join us in this fight. We will not allow the progress of the **20<sup>th</sup>** century to be dismantled in the **21<sup>st</sup>** century. ***“The struggle for justice is never finished, but in 2026, we have the opportunity to move the needle closer to equity for all South Carolinians.”***

## **CLERGY SUMMIT**

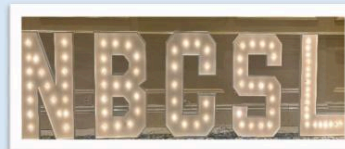
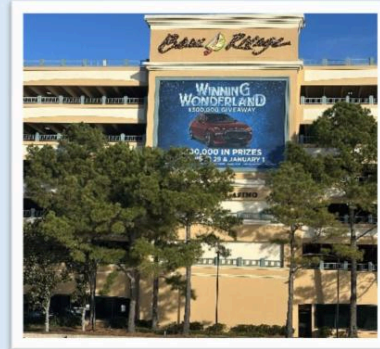
The South Carolina Legislative Black Caucus (SCLBC) hosted a landmark Clergy Summit, convening a statewide delegation of approximately 70 ministers across 30 denominations. The Summit offered a deep dive into the evolution of the Legislative Black Caucus, highlighting its pivotal role in the political process and its historical service to the Black community. Attendees were moved by "live history" presentations from Former Representatives Jim Felder and I. S. Leevy Johnson. Highlights included:

- **Historical Perspective:** The program featured foundational history provided by distinguished former legislators Jim Felder and I.S. Leevy Johnson, who detailed the SCLBC's legacy of legislative service.
- **Economic Empowerment:** In a commitment to economic development, the State Commission on Community Engagement presented on state contract certification for minority-owned enterprises.
- **Civic Mobilization:** The Summit concluded with a strategic call to action for increased ecclesiastical involvement in the political process and civic engagement. Following the event's success, the SCLBC has committed to a series of regional meetings to sustain this vital dialogue.

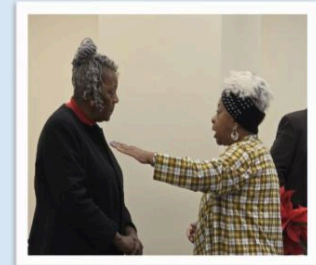

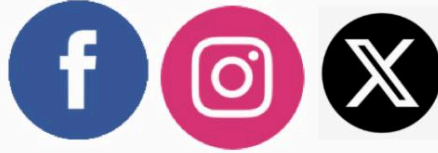
