The SECAC and PGCPS May 2025 Town Hall focused on increasing parent engagement. Janie Payne introduced the agenda, highlighting the CCAP Board election results and the follow-up from the March 2025 town hall. Survey results from the March meeting showed high satisfaction with the session's relevance and facilitators. Key issues discussed included the need for better communication, training for staff on managing diverse disabilities, and addressing the shortage of speech therapists. Parents emphasized the importance of accountability, equitable treatment, and the inclusion of general education staff in special education initiatives. The meeting concluded with a commitment to address these concerns and improve family engagement. The SECAC PGCPS May 2025 Town Hall focused on creating SMART goals and parental involvement in educational improvements. Speaker 24 emphasized the need for tangible changes based on data review. Speaker 25 praised the effectiveness of certain schools and urged parents to keep their email updated for surveys. Speaker 5 highlighted the importance of feedback and suggested setting small goals for progress. Board member Pamela Boozer commended the high engagement and parental voice. The meeting concluded with a call for survey feedback to improve future planning and support. Contact information and resources were provided for further concerns and follow-ups.

#### **Action Items**

- [] Create a parent advisory group to review data, set goals, and identify solutions to improve family engagement.
- [] Explore increasing the presence of social workers to support family-school collaboration.
- [] Address the shortage of in-person speech therapy services and make it easier for families to access private providers.
- [] Develop a standardized process for schools to communicate the IEP survey link to all families after meetings.
- [] Provide training for school staff on cultural competency and awareness of diverse family engagement styles.

# **Outline**

## Welcome and Introduction to the Town Hall Meeting

- Speaker 1 welcomes everyone to the SECAC and PGCPS Town Hall meeting and hands over to Janie Payne, the president of the SECAC board.
- Speaker 2 acknowledges the high attendance and explains the purpose of the town hall meetings, which aim to provide a forum for parents and engage on important topics.
- The agenda for the evening includes sharing the CCAP Board election results, follow-up from the March 2025 town hall meeting, and discussions on parent engagement.
- Speaker 2 introduces the new board officers for the 2025-2026 year, including Janie Payne (President), Samantha Dawson Williams (Vice President), Genevieve Janai (Secretary), and Alicia Baines (Treasurer).

#### **Recap of March 2025 Town Hall Meeting**

- Speaker 1 recaps the March 2025 town hall meeting, which focused on social, emotional learning and behavioral challenges in schools.
- Survey results from the town hall are shared, showing high levels of satisfaction with the session's relevance, Zoom format, date and time, and facilitators.
- Suggestions for future topics include strategies for de-escalation, staff counter-narratives for bias, universal accommodations, and training to help parents avoid absenteeism.
- Positive feedback from survey respondents includes looking forward to summer break, meeting end-of-year standards, and having free time to relax and spend with family.

#### **Special Education Town Hall Data**

- Speaker 1 provides summary data from the special education town hall, including 128 registrations and 75 attendees.
- 16 questions were received during the town hall, with 15 answered and one requiring direct follow-up.
- Seven recommendations were provided to PGCPS, which will be compared to questions from other town halls and addressed in the coming months.
- A written FAQ is available on the PGCPS website for further information.

#### Prince George's County Public Schools (PGCPS) Updates

- Speaker 3, Trinell Bowman, Associate Superintendent, provides updates on the recommendations from the April 2024 parent advocacy meeting.
- Ongoing initiatives include extracurricular activities and leadership opportunities for students with disabilities, and town hall meetings to address parent concerns.
- Professional learning training has been increased, with more daytime trainings for special educators and general educators.
- The inaugural special education institute was well-received, with over 300 attendees, including principals, support staff, families, and teachers.

# **Problem of Practice and Parent Engagement**

- Speaker 4, David Reese, explains the problem of practice consultancy model and the focus of the evening's town hall on increasing family engagement.
- The town hall will be structured as a collaborative work session to solicit recommendations and feedback on strategies for increasing family engagement.
- Designated note-takers will compile information for a comprehensive report to be provided to PGCPS at the end of the school year.
- The importance of using titles instead of individual names and refraining from discussing specific student cases is emphasized.

### Parent Engagement and Data Analysis

- Speaker 5, Yvette Young, discusses the importance of parent engagement and the data collected from the Maryland State Department of Education (MSDE) survey.
- The survey asks questions about parent satisfaction with school facilitation of parent involvement and the provision of information on agencies and organizations.
- The response rate for the survey has historically been low, with only 4-5% of surveys returned.
- The IEP survey after IEP meetings has a 4.4% response rate, and efforts are being made to increase parent participation in these surveys.

#### **Parent Concerns and Recommendations**

- Parents express concerns about the lack of responsiveness from principals and the need for better accountability and communication.
- Recommendations include training for staff on managing children with varying disabilities, providing resources for different learning modalities, and ensuring that compensatory services are provided as required by law.
- The importance of involving general education teachers and administrators in special education initiatives is highlighted.
- The need for awareness campaigns and standardized special needs departments across the county is emphasized.

#### **Final Reflections and Next Steps**

- Speaker 4 acknowledges the frustration expressed by parents and the need to address these concerns before moving forward with recommendations.
- The importance of using all communication channels to ensure that parents are informed and engaged is reiterated.
- Speaker 5 provides final reflections on the data presented and the need for ongoing collaboration and training to improve family engagement.
- The town hall concludes with a commitment to follow up on all questions and concerns raised during the meeting.

#### **SMART Goals and Parental Involvement**

- Speaker 24 emphasizes the importance of creating SMART goals and involving parents in the process.
- Parents are encouraged to review data and make tangible changes to address low-hanging fruit issues.
- Speaker 4 acknowledges the idea and mentions reaching out to specific parents and departments.
- Speaker 25 thanks the platform and shares a personal success story of their child making the honor roll with the help of the IEP team and administrators.

#### Parental Feedback and Survey Importance

- Speaker 25 stresses the importance of keeping email addresses up to date to receive and respond to surveys.
- Speaker 4 asks for comments from interpreters and thanks Lauren Boyd for holding her comment.
- Speaker 5 reflects on the heavy feedback received and the need for more avenues for expression.
- Speaker 5 mentions powerful suggestions, including setting small goals, and thanks a parent for acknowledging the role of social workers.

- Speaker 26, a board member, thanks the special education team and Dr. Reese for facilitating the session.

- Speaker 4 thanks Speaker 26 for her advocacy and accountability.
