

## **PROHIBITED ITEMS – SOUTH BANK MAJOR EVENTS**

To ensure the safety and enjoyment of all attendees, the following items are not permitted in the event site during major events (regardless of our usual Conditions of Entry) subject to the discretion of South Bank Corporation.

### **WEAPONS AND BLADES**

- Knives, blades, firearms, replica firearms, chains, bows or cross-bows, sling shots, studded belts, water pistols or weapons of any description are not permitted.
- Any item that may be considered a weapon or that has the potential to cause fear, injury, nuisance or inconvenience to another person is not permitted.

### **FOOD AND BEVERAGE**

- Alcoholic beverages must not be consumed, brought into or taken out of the event site, except where purchased and consumed in liquor-licensed venues at the event site.
- Any liquid other than water is not permitted.
- Glass or metal containers, including aluminum cans and bottles are not permitted.
- Opened/unsealed bottled water is not permitted. Bottled water with an unbroken factory seal is permitted. Empty drink bottles are permitted and may be refilled at designated water stations
- Homemade food is permitted if stored in non-glass containers.

### **PROHIBITED AND CONTROLLED SUBSTANCES**

- Controlled, dangerous, prohibited or illegal substances are not permitted.
- Pharmaceutical and prescription medications are permitted.
- Smoking and vaping are not permitted within the event site nor within 5 metres of entry and exit points.

### **HAZARDOUS OR FLAMMABLE SUBSTANCES**

- Aerosol cans (except for medical use), fuel, flares, fireworks, smoke bombs, explosives, open flames, gas canisters, LPG cylinders, laser pointers and lighters are not permitted.

### **RECREATIONAL ITEMS AND PROPS**

- Any item that could be used as a projectile or could create litter, such as helium balloons, confetti, streamers, shredded paper or glitter is not permitted.

- Any item that is deemed oversized and therefore could obstruct someone's view or pose safety risk is not permitted, such as:
  - Boogie boards, large inflatable items, oversized flotation devices
  - Tents, marquees or shade structures
  - Flags, large poles, banner stands.

## **DRONES OR REMOTE-CONTROLLED DEVICES**

- Drones, remote-controlled cars, model airplanes, remotely piloted aircraft or any electronic or motorised flying devices are not permitted, unless prior written authorisation has been provided by South Bank Corporation.

## **RECREATIONAL TRANSPORT**

- Recreational bicycles, recreational scooters, roller blades, segways, hoverboards, roller skates, skateboards or similar are not permitted.
- Mobility aids and prams are permitted.

## **ANIMALS**

- Animals are not permitted, except certified service animals accompanying a person for support.

## **OTHER PROHIBITED ITEMS**

- Any item or object, in the opinion of South Bank Corporation or its authorised security officers is deemed to risk the compromise of public safety, disrupt operations, cause harm to the reputation of the event or negatively impact the enjoyment of others.

## **By entering a major event at South Bank, you consent to:**

- Random handheld metal detector inspections
- Bag inspections
- No unaccompanied minors

**Please note:** To maintain a safe environment for this event, our security teams may intervene when unaccompanied minors (persons under 18) are identified as unsafe, at risk or causing disruption. Interventions may include conducting welfare checks, engaging with police, or removal or exclusion from the event and precinct.
