Introduction:

Pursuant to Reserve Bank of India (Non-Banking Financial Companies – Responsible Business Conduct) Directions, 2025 as updated from time to time (“**Directions**”) the Board of Directors have adopted a Fair Practices Code for the conduct of business of CapFloat Financial Services Private Limited (hereinafter “axio”/ “Company”). The Fair Practices Code (“**Code**”), as adopted herein below, is in conformity with the Directions.

The Company's business will be conducted in accordance with prevailing statutory and regulatory requirements, with due focus on efficiency, customer-orientation and corporate governance principles. In addition, the Company will adhere to this Fair Practices Code in its functioning.

Objectives:

- To ensure Fair Practice while dealing with the customers;
- To enable customers to avail our financial products and services basis informed decisions; and
- To ensure customer satisfaction.

Application for Loan and Processing:

- a) Loan application forms issued to prospective customers shall include necessary information without paving way for ambiguity, (so that a meaningful comparison with the terms and conditions offered by other NBFCs can be made and the borrower can make a voluntary and free decision). Loan application form shall clearly indicate the necessary documents to be submitted to avail the financial facility
- b) The Company has adopted a system of acknowledging receipt of all loan applications.

Loan Appraisal and Terms & Conditions:

- a) Loan applications will be considered and appraised as per the Company's appraisal norms and accordingly financial facility will be provided. An official communicate would be issued to the customer conveying in writing by means of a Sanction Letter, containing the details of the amount of loan approved along with the terms and conditions set therein, which includes the annualized rate of interest and its application thereof. In addition to which the penal charge on late repayment, NACH dishonor charges, Costs Processing fee, Prepayment charges is mentioned in explicit terms in the sanctioned letter and the loan agreement. The Company shall keep record of customer's acceptance of all these terms and conditions.
- b) Company shall, at the time of disbursement of the loan, furnish a copy of loan agreements and related enclosures quoted in the loan agreement to the customer.

Loans Sourced by NBFCs over Digital Lending Platforms:

- a. The Company shall maintain a website of its own in public domain, which shall be kept up to date, inter-alia, with the following details at a prominent single place on the website:
 - i. Details of all of its digital lending products and DLAs.
 - ii. Details of LSPs and the DLAs of the LSPs along with the details of the activities for which they have

been engaged for.

- iii. Particulars of customer care and internal grievance redressal mechanism.
- iv. Link to the Reserve Bank's Complaint Management System (CMS) and Sachet Portal.
- v. Privacy policies and other details as required under the Directions.

Disbursement of Loans and changes in Terms & Conditions:

- a) The Company shall give notice to all its borrowers of any change in the terms and conditions - including disbursement schedule, interest rates, service charges, prepayment charges etc. The Company shall also ensure that changes in interest rates and charges are effected only prospectively unless directed by the regulatory authority to the contrary. A suitable provision in this regard is incorporated in the loan agreement.
- b) Decision to recall/accelerate payment or performance under the agreement shall also be in consonance with the loan agreement.
- c) The Company shall release all securities on repayment of its full dues or on realization of the outstanding amount of loan subject to any legitimate right or lien for any other claim the Company may have against its borrowers. If such right of set off is to be exercised, the borrower shall be given notice about the same with full particulars about the remaining claims and the conditions under which the Company is entitled to retain the securities till the relevant claim is settled/ paid.

General:

- a) The Company will refrain from interference in the affairs of the customer except for the purposes provided for in the terms and conditions of the loan agreement (unless new information, not earlier disclosed by the customer, has come to the notice of the Company).
- b) The Company will not discriminate loan applications based on grounds of gender, race, caste, creed, community and religion. The company shall not discriminate in extending products and facilities including loan facilities to physically/visually challenged applicants on grounds of disability.
- c) In case of receipt of request from the borrower for transfer of borrower account, the consent or otherwise - i.e., objection of the Company, if any shall be conveyed to the borrower within 21 days from the date receipt of any request. Such transfer shall be as per transparent contractual terms in consonance with applicable law.
- d) With respect to recovery of dues, the same shall be carried out in accordance with the guidelines laid down by the regulatory authority. The Company shall not resort to undue harassment of the Customer viz., persistently bothering the borrowers at odd hours, use muscle power for recovery of loans etc. and ensure that its staff are adequately trained to deal with the customers in an appropriate manner.
- e) The Company shall not charge foreclosure fees on floating rate term loans for non-business purposes to individual borrowers, ensuring consistent policies with banks and NBFCs for customer protection.
- f) The Company shall make available the rates of interest and the approach for gradation of risks on the website of the Company.
- g) All communications to the borrower shall be in the vernacular language or a language as understood by the borrower. Company shall convey in writing to the borrower in the vernacular language as understood by the borrower by means of sanction letter or otherwise, the amount of loan sanctioned along with the terms and conditions including annualised rate of interest and method of application thereof and keep the acceptance of these terms and conditions by the borrower on its record.

- h) Company shall mention the penalties charged for late repayment in bold in the loan agreement.
- i) The Company shall provide a KFS to all borrowers to help them take an informed view before executing the loan contract, as per the standardised format provided in the Directions.
- j) The KFS shall be written in a language understood by such borrowers. Contents of KFS shall be explained to the borrower and an acknowledgement shall be obtained that they have understood the same.
- k) The KFS shall be provided with a unique proposal number and shall have a validity period of at least three working days for loans having tenor of seven days or more, and a validity period of one working day for loans having tenor of less than seven days.
- l) **The KFS shall also include a computation sheet of annual percentage rate (APR), and the amortisation schedule of the loan over the loan tenor. APR will include all charges which are levied by the Company.**
- m) Charges recovered from the borrowers by the Company on behalf of third-party service providers on actual basis, such as insurance charges, legal charges etc., shall also form part of the APR and shall be disclosed separately.
- n) Where the Company is involved in recovering such charges, the receipts and related documents shall be provided to the borrower for each payment, within a reasonable time.
- o) Any fees, charges, etc. which are not mentioned in the KFS, cannot be charged by the Company to the borrower at any stage during the term of the loan, without explicit consent of the borrower.
- p) The KFS shall also be included as a summary box to be exhibited as part of the loan agreement.
- q) Whenever reminders for non-compliance of material terms and conditions of loan are sent to borrowers, the penal charges shall be communicated. Further, any instance of levy of penal charges and the reason therefor shall also be communicated.
- r) Company shall give notice to the borrower in the vernacular language or a language as understood by the borrower of any change in the terms and conditions including disbursement schedule, interest rates, service charges, prepayment charges etc.
- s) Company shall also ensure that changes in interest rates and charges are affected only prospectively.
- t) Company shall comply with the Reserve Bank – Integrated Ombudsman Scheme, 2021, wherever applicable.
- u) *Company shall not charge EMI on the loan sanction amount without the knowledge or consent of the borrower.
- v) *Any changes in the amortisation schedule originally provided in the Key Facts Statement (KFS), with each part-disbursement of loan shall be promptly communicated to the borrowers.

Grievance Redressal Mechanism:

The Company has approved Grievance Redressal Policy and the same is placed in the website of the Company and is updated from time to time. The internal procedure on complaint management and mode available to the Complainant are duly updated in the Grievance Redressal Policy.

The Company has designated Principal Nodal Officer as Level 4 escalation for receiving and resolving

Penal Charges in Loan account:

The Company shall treat penalties for borrower non-compliance as 'penal charges,' not adding them as 'penal interest.' No interest will be computed on these charges, and regular interest compounding procedures in the loan account remain unaffected.

The Company will not introduce any additional component to the rate of interest and ensure compliance to these guidelines in both letter and spirit. The Company has formulated a Board approved policy on penal charges.

The Company will ensure to maintain reasonable and fair penal charges, proportionate to non-compliance with loan contract terms, ensuring no discrimination within a specific loan/product category.

The Company shall set penal charges for individual borrowers not engaged in business, ensuring they do not surpass charges for non-individual borrowers facing similar non-compliance.

With respect to penal charges, the Company shall transparently disclose details in the loan agreement, KFS, and on its website under Interest Rates and Service Charges. The Company shall communicate to the borrower regarding the levy of penal charge as per the extant regulations.

Regulation of Interest Rates charged by the Company:

The Company has laid down appropriate internal principles and procedure in determining interest rates, processing fees and other charges. The Company has adopted an interest rate model taking into account relevant factors such as, cost of funds, margin and risk premium, etc. and has determined the rate of interest to be charged for loans and advances which is in line with regulatory guidelines. The rate of interest and the approach for gradations of risk and rationale for charging different rate of interest to different categories of customers shall be communicated explicitly in the sanction letter.

The rates of interest and the approach for gradation of risks shall also be made available on the website of the Company. The information published in the website shall be updated whenever there is a change in the rates of interest

The rate of interest communicated shall always be annualised rate so that the Customer is aware of the exact rates that would be charged to the account.

Responsibility of Board of Directors:

The Board of Directors shall establish an effective grievance redressal mechanism within the Company, ensuring resolution of disputes at higher levels. They will also oversee periodic reviews of Fair Practices Code compliance and the redressal mechanism across management levels, submitting consolidated reports at half-yearly intervals.

Language and Communication of Fair Practice Code:

The Code shall be placed on the website of the Company and the same shall be made available in various vernacular languages for the information of stakeholders.

Loan facilities to the physically/visually challenged

Wherever applicable to the Company, Company shall not discriminate in extending products and facilities including loan facilities to physically/visually challenged applicants on grounds of disability. The Company shall render all possible assistance to such persons for availing of the various business facilities. Company shall ensure that its employees are suitably trained regarding the rights of persons with disabilities guaranteed to them by the law and international conventions.
