

## **Sovereign Minds Masterclass**

### **Terms & Conditions**

These Terms & Conditions govern your participation in the Sovereign Minds Masterclass (including your use of any associated Materials) (“the Masterclass”) provided by Sovereign Minds (the “Organiser”). By enrolling in the Masterclass, you agree to be bound by the following terms.

#### **1. Eligibility & Participation**

You confirm that you:

- have read, understood and agree to be bound by these Terms & Conditions;
- are over the age of 16; and
- take full responsibility for your own wellbeing throughout the program.

#### **2. Enrolment & Acceptance**

Enrolment is confirmed once payment (either full payment or deposit, where applicable) has been received. The Organiser reserves the right to refuse or cancel enrolment at its discretion, including in cases of breach of these Terms & Conditions.

#### **3. Fees & Payments**

##### **a) Payment Options**

The Masterclass fee is as stated at the time of enrolment.

##### **b) Deposits**

Where a deposit payment option is available and selected, the deposit secures your place in the Masterclass and is non-refundable and non-transferable.

##### **c) Balance Due**

If paying by deposit, the remaining balance must be paid no later than four (4) weeks prior to the official start date of the Masterclass.

Failure to complete full payment by this deadline may result in:

- cancellation of enrolment,
- forfeiture of the deposit, and
- loss of access to all Masterclass content and materials.

#### **d) Late or Missed Payments**

The Organiser reserves the right to withhold access to sessions, materials, or platforms if payment obligations are not met. Continued non-payment may result in termination of participation without refund.

### **4. Refund & Cancellation Policy**

All payments made toward the Sovereign Minds Masterclass are **non-refundable**, including deposits and instalments, except where refunds are required under applicable law.

- You acknowledge that non-attendance does not release you from payment obligations.

### **5. Transfer of Place**

Enrolment in the Masterclass is personal and may not be transferred to another individual or deferred to a future program unless expressly agreed in writing by the Organiser.

### **6. Program Changes or Cancellation**

The Organiser reserves the right to make reasonable changes to the Masterclass content, schedule, delivery format, or facilitators where necessary.

In the unlikely event that the Masterclass is postponed or cancelled by the Organiser, you will be offered either:

- a transfer to a rescheduled date, or
- a refund..

**7. Attendance, Access & Conduct** You are expected to engage respectfully with the Organiser and other participants. Disruptive, abusive, or inappropriate behaviour may result in removal from the Masterclass without refund.

Access to live sessions, recordings, or materials may be time-limited and is provided solely for the your own personal use.

### **8. Intellectual Property**

All materials provided as part of the Sovereign Minds Masterclass, including but not limited to recordings, workbooks, exercises, frameworks, and written or verbal content (the “Materials”) are the intellectual property of the Organiser.

You may not:

- copy, reproduce, distribute, sell, or share all or part of Materials;
- disassemble, decompile, reverse-engineer or create derivative works based on the whole or any part of the Masterclass or any associated Materials or attempt to do any such thing;
- access all or any part of the Masterclass or Materials in order to build a product or service which competes with the Masterclass or Materials;
- make alterations to, or modifications of, the whole or any part of the Masterclass or Materials or permit the Masterclass or Materials or any part of them to be combined with, or become incorporated in, any other programs;
- record sessions without explicit permission; and
- provide, commercially exploit or otherwise make available the Masterclass or Materials, in any form to any person.

## **9. Confidentiality**

You agree to maintain the confidentiality of:

- personal information shared by other participants, and
- discussions held within the Masterclass space.

This obligation continues beyond the completion of the program.

## **10. Privacy**

Your personal data will be processed by Organiser in accordance with the Masterclass Privacy Notice.

## **10. Personal Responsibility & Disclaimer**

You acknowledge that results from the Masterclass are not guaranteed. Any actions taken as a result of participation are done at your own discretion and risk.

The Organiser is not liable for any loss, injury, or damage arising directly or indirectly from participation in the Masterclass, to the fullest extent permitted by law.

## **11. Limitation of Liability**

To the maximum extent permitted by law, the Organiser's liability is limited to the total amount paid by you to the Organiser for the Masterclass.

## **12. Governing Law**

These Terms & Conditions are governed and construed and have effect in all respects in accordance with English Law and the courts of England shall have exclusive jurisdiction over any proceedings arising out of or in connection with them.
