Important Information.

- Colours may vary within a commercial tolerance (ISO105-A02) from batch to batch.
- Product specifications are based on averages from normal manufacturing tolerances. Such variations do not affect product performance.
- In the unlikely event of a claim, the supplier must register the claim, in writing, with the manufacturer within 1 (one) month of the delivery date of the product to you. The supplier must clearly state the nature of the manufacturing defect together with full details of the product so that the manufacturer can properly consider the claim.
- Pile pressure marks (for example due to furniture), texture or colour variation, shading and soiling shall not be accepted as a manufacturing defect.
- Returned products shall not be accepted unless such return is authorized by the manufacturer. Belgotex must be made aware of returns or claims for authorization.
- Claims for products that were damaged or wet in transit, shall only be considered by the manufacturer if the delivery note is endorsed to the effect that the wrapping or contents were damaged or wet at the time of delivery.

- Correct and regular maintenance will increase the lifespan of the rug and help to maintain its appearance. Cleaning should be proportional to the amount of soiling to which the rug is subjected.
