

# Terms of Service

The Chosen Clubs — Josiah Venture, NFP

*Last updated: 10 September 2026*

## 1. About These Terms

---

These Terms of Service ("Terms") govern your access to and use of thechosenclubs.com and the services offered through it (the "Services"), operated by Josiah Venture, NFP ("Josiah Venture", "we", "our", or "us").

By creating an account or using the Services, you agree to these Terms. If you do not agree to them, please do not use the Services.

The Services exist to help churches, youth workers and volunteers run Bible study clubs based on the television series The Chosen. They are provided free of charge.

## 2. Who May Use the Services

---

You may create an account if you are at least 16 years old, or the minimum age for consent to information society services in your country if that age is higher. That minimum age varies across the countries we serve; the version of these Terms in your language states the age that applies to you.

If you are below that age, you may only use the Services with the consent of a parent or legal guardian, and that consent must be given before you create an account.

Accounts are intended for club leaders, volunteers and others who support a Chosen Club. Participants in a club do not need an account to take part.

## 3. Your Account

---

When you create an account, you agree to:

- provide accurate and complete information, and keep it up to date
- keep your password confidential and not share your account with others
- tell us promptly if you believe someone has accessed your account without permission

You are responsible for activity carried out through your account. You may close your account at any time by contacting us using the details in Section 17.

## 4. Using Our Study Materials

---

Subject to these Terms, we grant you a limited, non-exclusive, non-transferable and revocable licence to use the study guides, leader resources, training videos and related materials we make available to you (the "Materials") for the purpose of running or taking part in a Chosen Club.

That licence includes the right to:

- download and print the Materials
- make copies for the members of your club

- display and use the Materials during club sessions, whether in person or online
- translate short extracts where needed to run your club in your own language

It does not include the right to:

- sell the Materials, or charge for access to them
- publish them on a public website, app store or file-sharing service
- remove credits, logos or copyright notices
- present the Materials as your own work, or as the work of another organisation

The Materials remain the property of Josiah Venture or its licensors. Rights in the television series The Chosen belong to its own rights holders and are not granted by these Terms.

## 5. Running a Club: Leader Responsibilities

---

If you use the Services to run a Chosen Club, you are responsible for the club itself. Josiah Venture provides materials and support; it does not organise, supervise or take responsibility for individual clubs.

Many Chosen Clubs include participants under the age of 18. Where that is the case, you and your local church are responsible for the safeguarding, supervision and consent arrangements required for those participants — including any parental or guardian consent required by law in your country. Josiah Venture does not obtain that consent on your behalf.

You also agree that:

- you will comply with the safeguarding policies and legal requirements that apply to your church, organisation and country
- you will not use our forms or services to submit personal data about club participants, particularly children, to us
- you will run your club in a way that is consistent with the purpose and spirit of the Materials

## 6. Content You Submit to Us

---

Some parts of the Services invite you to send us content — for example a message through our contact form, or a story about the impact of your club.

You keep ownership of what you send. By submitting it, you grant us a non-exclusive, royalty-free licence to store it and to use it internally to understand and improve the programme.

### If we would like to share your story publicly

We will ask you first. We will not publish your story, your name, your photograph or the name of your church in newsletters, on social media, on our website or in any other public material without contacting you and obtaining your agreement to that specific use. You may decline, or ask to be quoted anonymously.

A story about your faith says something about your religious beliefs, which receives additional protection under data protection law. Section 4 of our Privacy Policy explains the basis on which we handle it. You may ask us to delete anything you have sent us at any time.

When you submit content, you confirm that it is yours to send, that it does not infringe anyone else's rights, and that it does not include personal information about other people — particularly children — who have not agreed to it being shared. We may decline to use, or remove, any submission.

## **7. Acceptable Use**

---

You agree not to:

- use the Services for any unlawful purpose
- interfere with the operation or security of the Services
- attempt to gain unauthorised access to any system, account or data
- upload or distribute malicious software
- create accounts by automated means, or under a false identity
- use the Services to harass, endanger or exploit any person

## **8. Our Content and Trade Marks**

---

Except for the licence granted in Section 4, all content on the Services — including text, graphics, logos, videos, software and the Materials — belongs to Josiah Venture or its licensors and is protected by intellectual property law.

"Josiah Venture", "The Chosen Clubs" and associated logos are used under the arrangements between Josiah Venture and the rights holders of The Chosen. Nothing in these Terms gives you the right to use those names or marks other than as needed to run your club.

## **9. Privacy and Personal Data**

---

Our Privacy Policy explains what personal data we collect, why we collect it, the legal basis for each purpose, and the rights you have. It forms part of your agreement with us and is available in the same languages as these Terms.

Where these Terms and the Privacy Policy differ on a question of personal data, the Privacy Policy applies.

## **10. Third-Party Services and Links**

---

The Services rely on a small number of third-party providers, and may link to websites we do not operate — for example the official platform for watching The Chosen. We are not responsible for the content, policies or practices of third-party sites. Your use of them is governed by their own terms.

The providers who process personal data on our behalf are named in Section 7 of our Privacy Policy.

## **11. Availability and Changes to the Services**

---

We aim to keep the Services available, but we do not guarantee uninterrupted access. We may add, change, suspend or withdraw parts of the Services, including individual Materials, and may do so without notice where necessary for security, legal or operational reasons.

Where a change materially reduces what the Services offer you, we will give reasonable notice if we can.

## 12. Disclaimer of Warranties

---

The Services and Materials are provided "as is" and "as available". To the extent permitted by law, we do not warrant that the Services will be uninterrupted or error-free, that the content is complete or accurate, or that the Services are free of vulnerabilities.

This does not affect any warranty or guarantee you have under the mandatory law of your country.

## 13. Limitation of Liability

---

To the fullest extent permitted by law, Josiah Venture is not liable for indirect, incidental or consequential loss arising from your use of, or inability to use, the Services.

Nothing in these Terms limits or excludes our liability for death or personal injury caused by our negligence, for fraud or fraudulent misrepresentation, or for anything else that cannot lawfully be limited or excluded. If you are a consumer, this section does not affect your rights under the mandatory law of the country where you live.

Because the Services are provided free of charge, our aggregate liability to you for any other loss is limited to the maximum extent the law allows.

## 14. Suspension and Termination

---

We may suspend or close an account if the account holder breaches these Terms, uses the Services unlawfully, or puts the security of the Services or the safety of others at risk. Where it is reasonable to do so, we will tell you why and give you an opportunity to respond.

You may close your account at any time. Closing your account ends the licence granted in Section 4. Sections 6, 8, 12, 13 and 15 continue to apply after your account is closed.

Deleting your account also affects the personal data we hold about you; Section 12 of the Privacy Policy explains how to make that request.

## 15. Your Rights as a Consumer

---

Nothing in these Terms deprives you of the protection of mandatory provisions of the law of the country in which you habitually reside.

If you live in the European Union or European Economic Area, you keep all rights available to you under the consumer protection and data protection laws of your country, including the right to complain to your national data protection authority. Section 13 of our Privacy Policy explains how.

## 16. Language Versions

---

These Terms are published in several languages so that you can read them in your own. If you are a consumer, you may rely on the version in the language in which the Terms were presented to you. For all other users, the English version applies if the versions differ.

## **17. Changes to These Terms and Contact**

---

We may update these Terms to reflect changes in the Services or in the law. Where a change materially affects your rights or obligations, we will take reasonable steps to tell you directly.
