The commercial printing services include designing covers, layout and artwork of the documents, typesetting, printing, binding, lettershop and direct mailing. It is involved in the printing of promotional and advertising documents, textbooks and related educational publication. The financial printing services include designing covers, layout and artwork of the documents, typesetting, translation, uploading the documents to the stock exchange's Website, printing and distribution services for listing applicants in respect of listing on the stock exchange and companies listed on the stock exchange as well as standalone ad hoc design and artwork, and translation services to corporate customers.
