### **VOLUNTARY ANNOUNCEMENT** **STRATEGIC PARTNERSHIP WITH DRIVEEZ FOR WEB3 AND EV CHARGING** **INTRODUCTION**

Cornerstone Technologies Holdings Limited (“**Cornerstone**”) is pleased to announce that on 8 December 2025, the Company entered into a Memorandum of Understanding (“**MOU**”) with DriveEZ Limited (“**DriveEZ**”). The purpose of this agreement is to establish a strategic partnership to upgrade the Company’s electric vehicle charging ecosystem using blockchain technology.

#### **DETAILS OF THE COOPERATION**

Under this partnership, DriveEZ will act as the technical partner to Cornerstone for this new project. The collaboration focuses on integrating blockchain technology and Web3 infrastructure into the existing Cornerstone mobile application. Specifically, DriveEZ will develop and deploy an infrastructure adopting decentralized ledger technology that allows Cornerstone users to utilize EV charging or top-up their accounts using blockchain.

The parties also intend to build an ecosystem which will function as part of a loyalty and membership program. To support these functions, a Web3 portal will be embedded directly into the Cornerstone app, allowing users to easily view their loyalty program’s balances, memberships, and receive automated rewards based on their charging activity.

#### **REASONS FOR THE PARTNERSHIP**

The Board believes that partnering with DriveEZ will allow the Group to leverage new technologies to enhance user engagement and expand the EV charging ecosystem. By adopting blockchain technology into the user’s ecosystem, the Company aims to accelerate the adoption of sustainable charging solutions and build a stronger community of users through this Web3 initiative.

DriveEZ is a technology solutions provider specializing in Web3 development, cryptocurrency payment solutions, and blockchain infrastructure. They are the developers of this partnership, which is designed to enable green-energy business models through real-world asset tokenization.
