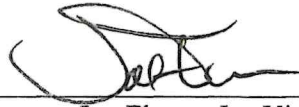
Lou Huerta moved to proceed with Project Sanchez and give Jorge Sanchez a 30-day notice of

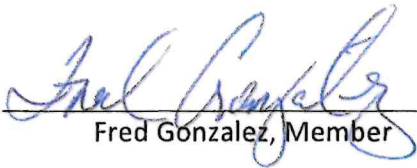
