Get your home energy rebate in 3 easy steps.



1. Complete upgrade.

Once your upgrade is complete, your contractor will submit your rebate to TVA EnergyRight for processing.



2. Claim your rebate.

Look for an email from TVA EnergyRight with your redemption code to claim your rebate.



3. Receive your rebate.

Allow 4–6 weeks for your rebate to be processed and delivered.

Your rebate questions answered.

What is the Quality Contractor Network?

All TVA EnergyRight rebate-eligible upgrades must be completed by a member of the Quality Contractor Network. Our membership in the network means our customers can trust that we are licensed, insured, and have been trained to meet TVA's quality guidelines.

Can I get TVA EnergyRight rebates and federal energy tax credits?

TVA EnergyRight home energy rebates can be combined with other energy rebate or credit programs. Review federal tax credits at [IRS.gov/credits-and-deductions-under-the-inflation-reduction-act-of-2022](https://www.irs.gov/credits-and-deductions-under-the-inflation-reduction-act-of-2022).*

Can I finance my home energy upgrade and still get a rebate?

Yes! If you qualify for financing, you can still take advantage of home energy rebates, as long as the financed project qualifies for a rebate. Financing may not be available in all areas. See if your local power company offers financing at [EnergyRight.com/Financing](https://www.energyright.com/financing).

How soon can I get my rebate?

Once the installation of your project is complete, we have 30 days to submit your rebate to TVA EnergyRight. Once processed, you'll receive an email asking you to confirm the installation details and claim your rebate. You have 60 days from the first email to claim your rebate. After 60 days, the claim is forfeited if it hasn't been redeemed. You can expect to receive your rebate within 4–6 weeks of completing the claim process.
