MOTIONS

PRACTICAL GRADING

Motion 1 SSNA

Practical grading to take place after initial paper grading has taken place for the following age groups in 2025:-

10 years and 16/17 years. To be held over 2 weekday nights

All teams will play in a round robin based on divisions they are placed kin by paper grading

Games will be 12 minutes in length

All results recorded and submitted to the graders

SSNA reserve the right to practically grade any age group it deems necessary.

CARRIED

Motion 2 EAGLES

Practical grading to occur for 10 years age group only

All other age groups are to be paper graded

Junior and Senior Grading Convenors will review ladders at Day 4 and should changes be made to a team this will occur at Day 8

No grading change requests can be made after appraisals/appeals

Any clubs affected by a grade change will be advised in writing prior to Day 6.

Motion 3 SHARKS

If practical grading happens there should be no changes to grades during the season.

LOST

Motion 4 SHARKS

If practical grading teams have less players than normal, they should not be able to borrow. If they don't turn up at all they are bottom of that grade. All teams to play a minimum of 4 games.

AI COMPETITION

Motion 5 SSNA

Any team forfeiting will incur a \$200 fine if done prior to Saturday and if forfeiting on Saturday will receive a \$500 fine.

LOST

Motion 6 SHARKS

Limit the number of premier league players in A1 teams.

LOST

BOYS

Motion 7 MENAI

That boys be allowed to play in 13-15 junior teams (mixed) in winter competition. That 16 plus boys be allowed to play in the senior winter competition alongside the girls.

LOST

Motion 8 Debbie Grimshaw

That all boys turning 14 years and over register with Sutherland so they can be placed in teams so a boy's competition can be arranged and play on Friday night

CARRIED

Motion 9 EAGLES

Any boy (over the age of 12) who is interested in playing netball register with the Association (SSNA) only to make teams(s). This team(s) should then play other association's boys' team.

LOST

Motion 10 SSNA

Boys playing in age groups above 12 years – Male players who have been registered player members for a club for at least 2 years from 10 years, 11 years and/ or 12 years be allowed to continue playing in 13 years age group for 2025. A maximum of two male players per team (mixed comp only)

METRO AND PREMIER LEAGUE

Motion 11 - Debbie Grimshaw

If a selected player in Metro is given a training partner contract with another franchise, then they would need to withdraw from their Metro team.

Motion 14 SSNA

A team may wear matching uniform in different styles (dress, shorts, singlet top) however the design (colours and patterns) must be matching across all pieces.

Motion 15 SSNA

Teams may play with four original registered players as per NNSW Rules, however, as per SSNA Competition Rules the maximum number of eligible players that team may borrow is two (2).

Motion 16 EAGLES

To even out the competition in all grades, with the implementation of 6 team grades.

SET UP

Motion 17 SSNA

All clubs will be allocated set up and pack down duties in the Winter Season. A schedule will be provided prior to Day 1 of play. Any clubs failing to complete their duty will be fined \$250.00

CARRIED

WET WEATHER

Motion 18 SHARKS

A day should be played unless extreme conditions such as thunder and lightning.

LOST

Motion 19 EAGLES

To have 2 allocated Sunday games in each round so that wet weather games can be played.

CARRIED

Motion 20 EAGLES

Games be played on a Saturday in final weekend of July school holidays.

CARRIED

Motion 21 EAGLES

If there are changes to the competition (eg. due to rain) that a zoom meeting be held with the Club Presidents prior to the decision being made.

Motion 22 SSNA

That the previous wet weather policy be revoked. Instead when a week is missed :-

The following week, two (2) half games are played (except in school holidays when they will be played the first game after school resumes). The game of the date is played first half and the wet week the second half game.

Teams go to the court and time indicated on the date in the official fixtures and are directed on the score sheet to the court for the second half game. NB this format is taken as TWO game for points or loss of points and TWO (2) games played.

Netsetgo games will strictly play to the game of the day. Washed out games can be rescheduled after game 14 up to a maximum of 3.
