The Department of Health & Human Services, through an interim final rule issued November 2, 2011 (76 Fed. Reg. 67992 (Nov. 2, 2011)) and a final rule issued October 29, 2015 (80 Fed. Reg. 66726 (Oct. 29, 2015)) by CMS and the Office of Inspector General ("OIG"), has provided certain waivers of federal fraud and abuse laws in connection with the Shared Savings Program, for arrangements entered into by Accountable Care Organizations (hereinafter "Final Waivers").

PBACO Holding, LLC ("PBACO") was formed for the purposes of participating in the Medicare Shared Savings Program as an Accountable Care Organization ("ACO"). In accordance with the public disclosure requirements of the Final Waivers, PBACO hereby discloses the following arrangement, protection for which is provided by the Participation Waiver.

#### Arrangement #1. – Yupana.

**Parties to the Arrangement:** The parties to the arrangement ("Arrangement") are PBACO Holding, LLC ("PBACO") and Yupana Health, Inc. ("Yupana").

Date of the Arrangement: September 9, 2024.

**Purpose of Arrangement:** To engage in a collaborative research initiative for purposes of evaluating healthcare costs and supporting care utilization management and education for Medicare beneficiaries attributed to PBACO.

Items, Services, Facilities and/or Goods Covered by the Arrangement: The incentive payments are made to PBACO and are intended to improve care utilization management, communicate clinical knowledge and evidence based medicine to beneficiaries, and promote accountability for the quality, cost and overall care of Medicare beneficiaries attributed to PBACO.

#### <u>Arrangement #2. – Trustbridge.</u>

Parties to the Arrangement: The parties to the arrangement ("Arrangement") are PBACO Holding, LLC ("PBACO")

and Trustbridge, Inc. ("Trustbridge").

Date of the Arrangement: February 3, 2021.

**Purpose of Arrangement:** A collaborative arrangement intended to (1) evaluate the health needs of PBACO's attributed Medicare beneficiaries, (2) promote evidence-based medicine and beneficiary engagement, (3) support PBACO's functions in improving the health of Medicare beneficiaries attributed to PBACO, (4) improve the beneficiary experience of care, and (5) reduce the costs of care, consistent with the goals of the Shared Savings Program.

Items, Services, Facilities and/or Goods Covered by the Arrangement: PBACO and Trustbridge share the implementation and subscription costs of ClosedLoop Services, in order to improve the care of Medicare Beneficiaries and costs outcomes, with the purpose of fulfilling the Triple Aim established by the MSSP.
