1. INTRODUCTION"		
Who are we?	We are SkillCorner SAS ("SkillCorner", "we", "us"), a company incorporated and registered in France, with a registered address 2 rue des Quatre-Fils, 75003 Paris.	
	Where we decide the means of, or purposes for, processing your personal data, we are the "controller."	
What's this notice about?	This notice explains how we collect and use personal data, as a controller, in relating to the following groups of individuals:

# 2. HOW WE USE YOUR PERSONAL DATA

# Website Visitors

 $\underline{\textbf{What information?}}$  – We collect and use the following information:

- Technical data: includes (i) information relating to the device which you use to access our Website, and information relating to such device (including IP address, screen resolution, operating system, and browser type and version); (ii) identifiers used to identify you when you visit our Website; and (iii) information about how you interact with content on our Website (such as the pages you visit or the content which you engage with). We collect this information using the technology described in Section 4 of this Privacy Notice.
- Recruitment data: includes your name, email address and any information relating to you which you share
  with us (including your CV) for recruitment purposes. We collect this information when you submit job
  enquiries to us at <a href="mailto:contact@skillcorner.com">contact@skillcorner.com</a>, via forms on our Website, via recruitment platforms or via
  recruitment agencies.
- Enquiry data: includes your name, email address and any other information relating to you which you share
  with us. We collect this information when you email us at <a href="mailto:contact@skillcorner.com">contact@skillcorner.com</a>, or message us via the
  "Find out more" section of our Website.
- Marketing data: includes your first name, email address and your marketing communication subscriber
  preferences. We collect this information when you procure services from us, or when you opt-in to receive
  marketing communications from us (e.g. via our Website).

### Why are we using this information?

- **Technical data:** to correct technical errors and bugs on our Website, make technical updates and improvements to our Website, and understand how you use our Website.
- Recruitment data: to receive job enquiries, assess whether individuals are suitable to work with or for us (by considering skills, experience, qualifications and general competency), communicate with applicants about recruitment processes, and maintain appropriate records relating to recruitment processes.
- Enquiry data: to respond to your questions, requests and complaints.
- Marketing data: to send you information about our business, services and products.

### How are we using this information / what is our legal basis for doing so? -

- **Technical data**: in some cases, we are able to use this information because you have given your consent to us doing so. In other cases, we are able to use this information because it is necessary for our legitimate interest in promoting the success of our business and furthering our commercial interests, or our mutual legitimate interest in improving our services and products.
- Recruitment data: we are able to use this information because it is necessary for our mutual legitimate
  interest in ensuring that you are the right candidate for the role, suitably qualified and experienced, and that
  the terms of your prospective employment or engagement meet our mutual expectations and business
  objectives.
- Enquiry data: we are able to use this information because it is necessary for our legitimate interests in
  promoting the success of our business and furthering our commercial interests; or our mutual legitimate
  interest in improving our services and products, ensuring that you have a positive experience when using our
  services, and ensuring that you receive good customer care.
- Marketing data: in some cases, we are able to use this information because you have given your consent to us
  doing so. In other cases, we are able to use this information because it is necessary for our legitimate interest
  in promoting the success of our business and furthering our commercial interests, or our mutual legitimate
  interest in ensuring that you are informed about products, services and business updates which you may be
  interested in.

<u>How long do we use this information for?</u> – We retain this information for as long as it is reasonably necessary to do so, taking into account the purpose for collecting and using the relevant information. The specific retention period may vary based on factors such as:

- **Technical data**: any retention requirements imposed by third-party service providers which are used to collect this information; whether the error or bug which the information relates to, has been resolved; or whether we need to continue retaining the information in order to finalise any updates or improvements to our Website, or maintain the ongoing safety and security of our Website.
- Recruitment data: whether you are successful with your job application (where we will retain this information for [two] years following the end of your employment or engagement with us), or unsuccessful (where we will retain this information for [two] years following the submission date of your application).
- Enquiry data: whether the issue which the enquiry relates to has been resolved.
- Marketing data: whether you inform us that you no longer wish to receive SkillCorner's marketing communications.

### **Customer Personnel**

**What information?** – We collect and use the following information:

- Business data: includes your name, work email address, work telephone number, Slack profile details, company, role and any information relating to you which is included in any correspondence, materials or other information which you or your company share with us, in relation to the provision of our services. We collect this information from you in advance of, and during, the provision of services to you or your company.
- Service usage data: includes information about your use of our services, including your use of the SkillCorner API and SkillCorner Web App, which features and tools you use, what data you access (and when and how), any feedback which you provide on our services (including via surveys). We collect this information using the technology described in Section 4 of this Privacy Notice.
- Technical data: includes (i) information relating to the device which you use to access our services, and information relating to such device (including IP address, screen resolution, operating system, and browser type and version); and (ii) identifiers used to identify you when you use our services. We collect this information using the technology described in Section 4 of this Privacy Notice.

<u>Why are we using this information?</u> – We use the business data to provide you or your company with our services, and administer our relationship with you and/or your employer. And we use the technical data to understand how you use, and to improve, our services; and correct errors and bugs in our services.

<u>How are we using this information / what is our legal basis for doing so?</u> – We are able to use this information because it is necessary for our legitimate interest in promoting the success of our business, delivering high-quality services and furthering our commercial interests.

<u>How long do we use this information for?</u> – We retain service usage data for 1 year. For the remainder of this information, we retain it for as long as it is reasonably necessary, taking into account the purposes and objectives set out above. The specific retention period may vary based on factors such as:

- The nature and status of the relationship between SkillCorner and you (or your company).
- Any legal or contractual obligations, which SkillCorner is subject to, which dictate how SkillCorner shall retain the relevant information.
- Whether SkillCorner needs the relevant information to improve its services and products.

### **Sportspersons**

<u>What information?</u> – The information which we collect and use for each Sportsperson depends upon the sports in question. Specifically, we collect and use the following information:

In most cases, this data is generated from video footage, using our automated technology. The underlying video footage is provided to us either by our data partners (which includes third-party sports and performance analytics providers and scouting platforms), or our customers. In other cases, this data is collected directly from our data partners, without using our automated technology (e.g. player metadata).

<u>Why are we using this information?</u> – We use this information to provide our services to our customers, and to improve the delivery of those services.

<u>How are we using this information / what is our legal basis for doing so?</u> – We use this information because it is necessary for our legitimate interest in promoting the success of our business, delivering high-quality services and furthering our commercial interests.

<u>How long do we use this information for?</u> – We retain this information for as long as it is reasonably necessary, taking into account the purposes and objectives set out above. The specific retention period may vary based on factors such as:

- Whether the individual is still competing in the relevant sport, and in which competition they are competing.
- Any legal or contractual obligations, which SkillCorner is subject to, which dictate how SkillCorner shall retain the relevant information.
- Whether SkillCorner needs the relevant information to improve its services and products.
- Any retention requirements imposed by the third-party data partners from whom we collect this information (or the underlying video footage from which this data is generated).
