Textual Information(1)	Vinsan Brothers Private Limited and Shankar Sales Promotion Private Limited were Promoter Group members of the Company as on 30 September 2025. However, as intimated to the Stock Exchanges vide the Companys letter dated 03 December 2025, both entities have merged with Satellite Finance Private Limited, which is also a Promoter Group member, pursuant to a Scheme of Amalgamation. Consequent to the merger, 42,51,619 equity shares earlier held by Vinsan Brothers Private Limited have vested in Satellite Finance Private Limited by operation of law. As on 31 December 2025, 31,68,927 equity shares have been credited to the demat account of Satellite Finance Private Limited, while the balance 10,82,692 equity shares, held in a separate demat account of Vinsan Brothers Private Limited and pending credit to the demat account of Satellite Finance Private Limited, continue to be disclosed under the Promoter Group in the name of Vinsan Brothers Private Limited. Shankar Sales Promotion Private Limited did not hold any equity shares of the Company and, pursuant to the approved scheme, stands dissolved without winding up. Accordingly, its name has been removed from the Promoter Group category.
